Prince Frederick Parish Lanes County South Carolina Planter
being as Pursuant of bad health of Body but sound & Perfect mind
& memory Considering the frailty of mans Life and the uncer-
-ainty of my death and therefore resolved to order my affairs in
my own time that all the Differences that may fall out hereafter
after my decease may be Obviated & prevented & therefore I make my
Last will & Testament as follows that is to say first Principally
I Recommend my soul into the hands of Almighty god hoping
through the merits death & Passion of my Saviour Jesus Christ to
have a full & free pardon of all my sins & to Inherit Everlasting
Life and my Body I Commit to the earth to be decently buried
at the Discretion of my Exr. after ment. and as touching
the Disposition of all such Temporal Estate as it had pleased
Almighty god to bestow upon me I Give and Dispose
thereof as follows first I will that all my Lawfull debts
be paid and discharged as also my funeral charges & charges
will that my Exr. Provide a maintenance for my wife
and as my charge to see the Crop beat out of which I owe
to have one third of Every part & Parcel thereof and I will
that my two negroes Rut^{xx} and Inden be kept Employed
with Mr Elisha Scourus negroes till the Crop is beat out
and Immediately after sold as also my third of the Crop as
for my horse & mair & yearling household goods &c may
be sold at any convenient time sooner I do will that what
money is over & above paying my debts be Equally divided
between my Brothers John Shannon James Shannon William
Shannon & David Shannon in Lanes Parish in the County
of Down in Ireland Shan & Shan alike & in case of the
decease of any of my Brothers above ment. that his
share be Equally divided

the Lawful Offis^r and I hereby nominate
constitute & appoint Alex^r Hardson whole & sole Exr.
of this my Last will & Testament and I do hereby Revoke
disannul and make void all former wills by me
heretofore made In Witness whereof I the said
Robert Shannon to this my Last will & Testament have
set my hand & Seal this third day of Nov^r one
thousand seven hundred & fifty & in the twenty third year
of his Majesty's Reign
