Item I do Give and Bequeath unto my well beloved Daughter Esther Jackson one Bed & furniture as also one hundred and fifty pounds Lawfull money to be paid her yearly and every year during her life out of my Estate (that is to say) out of the three Divisions — hereafter mentioned, for her maintenance and if any of the Sum is not expended at the end or Term of any year it shall be put to Interest for her Use only. Item I do Give and Bequeath unto my beloved Son Charles Butler my new Gun to him & his Heirs forever. Item I do Give and Bequeath all the remainder part of my Estate after paying my just and Lawfull Debts & Legacies above mentioned to be equally divided into three parts between my beloved Wife Jean Jackson my beloved Son John Jackson and my beloved Daughter Jean Butler to them and their Heirs forever. And Lastly I do make constitute ordain and appoint my well beloved Wife Jean Jackson Executrix my beloved Son Charles Butler and my loving Brother George Jackson Executors of this my last Will & Testament

In the Name of God Amen this twenty fifth day of April one thousand seven hundred and forty eight I William Cornin of Edisto Island in the Province of South Carolina being Sick in Body but of Sound memory and perfect Judgment praise be given to God for the same and knowing the uncertainty of human life on Earth and being desirous to settle my affairs and things in order do make this my last Will & Testament in manner and form following; that is to say first and principally I commend my Soul to Almighty God my Creator assured by believing I shall receive full pardon and free remission of my Sins and to be saved by the precious Death and Merits of my blessed Saviour and Redeemer Christ Jesus and my Body to the Earth from whence it was taken to be buried in such decent and Christian manner as my Executors hereafter named

shall be meet and proper and touching such Debts and Wobbliged as I have in every hath lent me, my Will and meaning is the same shall be employed and paid as hereafter by this my Will is Express'd. And first I revoke annul and frustrate & make void all Wills by me formerly made and Declare and appoint this only to be my last Will and Testament Supprimis after paying my Lawfull & just Debts I will and Bequeath to my Cousin John M<sup>c</sup>Kulloch & his Wife Betty — M<sup>c</sup>Kulloch the Brop now up on the Ground all my Stock of Hogs the two Cows all my Household Goods Excepting my Body Bloattes which I leave unto Andrew and John M<sup>c</sup>Karlies as also two Guns and Muster Accoutrements I Give & Bequeath unto the Presbyterian Church upon Edisto Island for the support of a Minister whose principals is Agreeable to the Established Fundamentals of the Church of Scotland a negro Man named Prophet also a negro Girl named Hanna and all my Horn'd Cattle I will and Bequeath unto David Alexander of Edisto Island a negro Wench named Chloze for his and his Heirs use in my Pleasure that John M<sup>c</sup>Kulloch Sen<sup>r</sup> give unto his Daughter Mary M<sup>c</sup>Kulloch thirty pounds Currency I Give John M<sup>c</sup>Kulloch Sen<sup>r</sup> the use of the following negroes during the natural Life of his Wife Betty M<sup>c</sup>Kulloch Vir<sup>g</sup> Caesar, a wench Rose, Dollie, Marya, & Rose and upon the Decease of his said Wife then these negroes to be sold at Vendue and the money to be equally divided betwixt the above named Hance Andrew and John M<sup>c</sup>Kulloch Jun<sup>r</sup> and Andrew and John M<sup>c</sup>Karlies and the said M<sup>c</sup>Karlies part to be put on Interest by the s<sup>d</sup> Hance Andrew and John M<sup>c</sup>Kulloch till the said M<sup>c</sup>Karlies is of age when they are to have their part Lastly it is my Will and pleasure that the negro man I have given fo the use of the meeting House & the Wench I have left David Alexander remain upon this plantation till the Brop now upon the ground is made and hoking is over then to be applyed for the uses above mentioned I appoint constitute and Ordain William Edings Sen<sup>r</sup> James Butcher and William Jenkins of Edisto Island as Executors to this my last Will and Testament as

I desire as soon as possible after my decease that my Executor will make Sale of all my Estate or Effects whatsoever (except my negro man Paris) And that my debts funeral Expences & Legacies may be Satisfied & paid as soon as possible can be done. I give & bequeath to all my Relations or kindred One Shilling each if demanded within twelve months after my decease. I give & bequeath to Mrs Frances Lescott Widow Fifty pounds Lawfull money of S<sup>c</sup> Carolina. I give & bequeath to John Raper nephew of Robt: Raper of Chas: Town One hundred pounds Lawfull money of S<sup>c</sup> Carolina. I give & bequeath to Robt: Raper aforesaid One hundred pound Curr<sup>t</sup> for his trouble in settling my Affairs after my decease. And my positive will and desire is that my negro man Paris shall not be sold, but shall be a freeman from all Servitude — whatsoever from & after the day of my decease. I give devise & bequeath to the Church Wardens of S<sup>c</sup> Philipas Parish Chas: Town for the time being

All the remainder of my Estate Real or personal To be disposed to such Charitable uses as they shall think proper to poor People residing in the said parish. And Lastly I do hereby nominate and Appoint Robt: Raper of Chas: Town Executor of this my last Will & Testament In Witness whereof I have hereunto set my hand and Seal this 25<sup>th</sup> day of May 1748 In the Twenty first year of his Majesty's Reign
