hundred Bay mare to have & to hold for ever Item I give and bequeath
to my beloved Friend Joseph Bowrey Jun one Dun Horse to have and to hold
for ever Item I give and Bequeath to my Beloved Friend Joseph Bowrey
Senr one black Mare to him and his heirs for ever Item I give and beqth
to my Beloved Brother Allen M Lane after all my Lawful debts and
legacies is paid of as above mentioned all my Real Estate and Personal
Estate to him and his heirs for ever Lastly I do Likewise constitute &
appoint my Beloved Brother Allen M Lane and my Beloved Friend Joseph
Bowrey as my true and Lawful Executors To this my last will and Testam^t
