partys share may more clearly appear And leave it to the discretions of
my Executors either to put at Interest on such Security as they shall thin
proper, or to purchase Slaves, with the monies that shall appear to be my
Daughters share, as aforesaid And Lastly I do hereby nominate constitute
and appoint my said wife Executrix and my Brother in Law M^r John
Freer Executor of this my will hereby revoking all former Will by me at
any time made In Witness whereof I have to this my Last Will and Tes-
tament, Contained in two Sheets of Paper and Labelled together with my hand
and Seal The Thirty first day of October In the Year of our Lord One thou-
sand, seven hundred and fifty eight?

and bequeath to Mary my Eldest daughter four hundred and fifty
pounds including a Receipt from her Husband given to me as part
thereof which shall be her part of my Estate in this Province as above
Item I also appoint to said John & Mary a Legacie bequeathed to me
by my Father in Law Arch bald Stewart in Ireland to be Equally Sha-
red between them Item my whole Remaining personal Estate my
books and wearing apparel only Excepted I will and bequeath to
my five youngest Children that is to say James Robert Elther
and Jannett to be Equally Shared to each of them and if any of
them die before they arrive at Maturity then their Respective Shares
or shares shall revert Equally to the surviving of those Youngest five
only Item I also bequeath to those youngest five Children twenty
pounds sterling being a debt due to in Ireland Equally to each of them
if it can be Received to them Item I leave my wearing apparel be-
fore reserved to my Son John and my Books I leave to be Equally Shared to all my
seven children and all my Other Estate in the manner following that is my
two Eldest Children shall Receive their Share one Year after my Decease
and my five youngest Children's part to be in the hands of Executors after
named until they come to Maturity and a Majority of Executors shall dispo-
se of it for their Use till they come of Age as they see proper Item I appoint
my Son John Gavin Witherspoon William Dobin and William James
Executors of this my Last Will & Testament and I utterly Revoke disallow
and Annul all other Wills Testaments and Executors by me in anywise
named before this day Ratifying and confirming this and no Other to be my
