in law Nancy Todd Daughter of my said wife and unto my son Robt
Bonnor son of the said wife all and singular my Real and Person-
al Estate I give devise and bequeath the same and every part
or parcel thereof unto my said wife Susannah Bonnor and her daugh-
ter Nancy Todd and my son Robert Bonnor the son of the aforesaid
Susannah and Henry Bonnor to have and to hold the same and every
part and parcel thereof unto them the said Susannah Bonnor
Nancy Todd and Robert Bonnor the youngest and last son of my body
their heirs executors administrators and assigns for ever After an equal parti-
tion should be made allowing my said wife Susannah to draw
her Part or Parts as soon after my decease as she shall think proper
My said Daughter above mentioned Nancy Todd and my son Robert
aforesaid one them and their their Part or Parts to be drawn
at the age of sixteen or the day of marriage and lastly I do now
make constitute and appoint my wife Susannah Bonnor and
Benjamin Godfrey printer in Charles town to be
