 finding my self very weak of body but of sound mind and Memory have Consti-
 tuted ordained and appointed this as my Last Will and Testament do Commit
 my soul into the hands of Almighty God and my body to be buried in a decent
 Christian way at the Discretion of my Executors Item I do dispose of all my
 Personal Estate in the following manner after all my Just debts is Paid Viz
 I give and bequeath unto my beloved wife one third of my Personal Estate and
 the Remainder Part to be Equally Divided among my Children as they
 come to proper Age Viz the Money arising from my Children's parts after said
 to be put out at Interest Witness my hand and Seal this Seventeenth day
 of November One thousand Seven hundred and Fifty seven N.B. Mary Denly

In the Name of God Amen Benjamin Ladson of the Island of St Helena &
 Granville County and Province of South Carolina Planter being very sick & Weak
 of Body yet being of a sound and disposing mind and Memory and Understanding
 through the Mercy of God do make and Ordain this my Last Will and Testament in
 manner and form following That is to say First and Principally I resign my soul
 with the utmost Humility into the hands of Almighty God my Creator humbly hoping
 for a blessed Immortality through the Merits and Mediation of my blessed Saviour
 and Redeemer Jesus Christ and my body I desire may Decently be buried as my
 Executors herein after ^{named} may Judge best And as to my Worldly or Temporal Estate
 as he hath Intituled me with I have devised and bequeath thereof as follows
 Imprimis and first of all I Will that my funeral Charges and Just debts be
 discharged with the first Convenience Item I Will and Order that my Executors
 and Executors do pay as it may be wanted from Time to Time for the Cloathing
 500 Years schooling and Binding out Apprentice John the son of John Linn
 so that the Whole sum do not exceed Forty Pounds Currency Money ~~for~~
 the above Uses only, Item I Will and Order that my Wearing Apparel be given
 unto my Brother Samuel soon after my Decease Item I bequeath all my
 Land on St Helena containing two hundred Acres more or less to be Divided
 My sons Benjamin & Thomas (and the Infant of which My Wife Elizabeth is
 Pregnant of, if it should prove a boy but not otherwise) soon after the Decease
 of my said Wife and not before but after her decease to My son Benjamin
 and Thomas And to the said Infant if a boy and not otherwise and to their
 heirs for ever Item I Will that the rest of Residue and Remainder of
 all

all my Personal Estate Negroes Goods Cattle Horses and Chattels of any
sort be Equally divided into Two Moieties or half Parts immediately after the
discharging my Just debts if my Executors & Executors shall Judge convenient
One Moiety or half Part to be Equally divided between my sons Benjamin
and Thomas and the Infant now in the Womb as yet unborn and their heirs
for ever. Item I Will and Order that my Dearly beloved Wife have and enjoy
my Lands and Houses on St. Helena during her Natural Life and no longer
I Give the other Moiety or half Part of all the rest Residue and Remainder
of my Personal Estate before mentioned unto my said Wife Elizabeth and her
Heirs for ever And I do hereby nominate and appoint my said Dearly beloved
Wife Elizabeth Executrix together with my Brother Peter Perry and my Good
friend John Tripp and William Tripp to be Executors to this my Last Will
and Testament and I hereby Revoke and Disannul all former Wills
and Legacies by me made and left before at any time and Declare this
to be and contain my Last Will and Testament I Witness Whereof
I have to these presents set my hand and Seal this Twentieth day of Sep-
tember in the 31st year of his Majesty's Reign and of our Lord One thousand
Seven hundred and fifty seven

of December in the thirty first Year of the Reign of our Sovereign Lord King
George the second in the year of our Lord One thousand Seven hundred and
fifty seven Petrus Dandridge of St. Pauls Parish in the Province
of South Carolina Planter being sick and weak in body but of sound and
clearing mind and Memory and considering the Uncertainty of this Trans-
itory Life and the Certainty of Death do therefore make Publish and Declare
this my Last Will and Testament in manner and form following that is to
say Principally I commend my soul to the Mercy of God my Creator and
trust to Receive the Pardon of all my sins and Obtain Eternal Life and
my body at Death I commit to the earth to be decently Interred at the
Discretion of my Executors herein after named. And as to such worldly Estate
as it hath pleased God to bestow on me in this Life I hereby Will and Dispose
of the same in Manner and form following Imprevius I Give and bequeath
unto my beloved Wife Elizabeth Dandridge all that Parcel or Tract of Land
whereon I dwell at St. Pauls Parish in the Province aforesaid
containing Two Hundred Acres butting on the North side on Land belonging
to Isaac Nichols to the Eastward on Land belonging to Captain John Smith
to the Southward on Land the Property of John Elliott and to the Westward
on Land belonging to Capt^o Thomas Leno Elliott for ever. Item I Give & Bequeath
unto my said Wife Elizabeth Dandridge all those my Black Negro Slaves known
by the Names of Cupid Rose and her Child Phillis Patience & her Daughter
Leston together with all my House hold furniture wheresoever or what soever
to her & her Heirs for ever. Item I Give and Devise and Bequeath unto
