and Commander of His Majesty's Fort-Johnson, in this Province being
very weak in Body but of sound and disposing Memory and understanding
thanks be given to almighty God for the same Calling to mind the Uncer-
tainty of this Mortal State and knowing that it is appointed All Men
Once to die, and being desirous to settle my Temporal Affairs before my
great Change comes, do therefore make and declare this my last Will
and Testament in Manner and form following that is to say, I give
my Will and Order that all my just debts and Funeral Expence be
paid and discharged with all convenient Speed after my Decease.
Item I give and bequeath unto my Sister Mary Battelle the sum of
One hundred pound Currency to be paid her at the Expiration of one
year after my Decease and a Suit of Mourning. Item I give and be-
queath unto my Brother Joseph Lloyd, my sword, Cuttce and Pistols
also all my Outside wearing Cloaths and Six Compleat Suits of my
Linnen Cloaths and also a Suit of Mourning. Item Whereas I am
possest of a Large Quantity of household Furniture and Plate more
than sufficient (in all Probability) for the Convenience of my wife &
Daughter after my Decease. Therefore I will and desire that my Executors
and Executors at their Discretions do sell such part thereof for the pay-
ment of my debts or towards the same as they shall Judge most proper.
Item I give devise and Bequeath unto my dearly beloved Wife Rebecca
Lloyd and to my dearest Daughter Rebecca Lloyd all the rest and Residue
of my Estate Real and Personal whatsoever and wheresoever of what
nature or Kind soever to hold the same to them and their heirs Executors
and Administrators Equally to be divided. And my will and mind is that
my Daughters share or part of my said Estate be delivered her at the Age
of Twenty one Years or day of Marriage which shall first hapen And
in case it should so hapen that my said Daughter should depart this
Life before she attains her Age of Twenty One Years or day of Marriage
Then And in such Case I give devise and Bequeaths such part of my
Estate as is hereinbefore given to my said Daughter Equally to be divided
between my said wife and my Nephew Nathaniel Fuller to them and
their Respective Heirs Executors and Admors for Ever But in case my
said Nephew should hapen to be dead at the Time of such Contingency
happening or before his Age of Twenty One Years Then I give devise and
Bequeath the whole thereof to my said Wife and to her heirs Executors and Admors
for Ever And I do Recommend to my said Executors and Executor
that my said Estate be carried On managed Occupied and Improved

Wth In the same way and manner that I myself have done it for some time
past to wit in the Planting Tobacco and in raising of stock during the
Daughters Minority or until her day of marriage and that after payment
of my Debt Maintenance and Support of wife and daughter and also my Da-
ughters Education and other Incident and necessary Charges and Expens-
es of my Estate the Profits Issues and proceeds thereof be Annually apply-
One half to the use of my said Wife, and the other to my Daughters use
and Benefit as their separate Interest and Estate And that my Executors
and Executor do keep particular and separate accounts thereof that each
partys share may more clearly appear And leave it to the discretions of
my Executors either to put at Interest on such Security as they shall thin
proper, or to purchase Slaves, with the monies that shall appear to be my
Daughters share, as aforesaid And Lastly I do hereby nominate constitute
and appoint my said wife Executrix and my Brother in Law M^r John
Freer Executor of this my will hereby revoking all former Will by me at
any time made In Witness whereof I have to this my Last Will and Tes-
tament, Contained in two Sheets of Paper and Labelled together with my hand
and Seal The Thirty first day of October In the Year of our Lord One thou-
sand, seven hundred and fifty eight?

Divided only with this one Exception if in case my wife shall be com-
with child be it male or female then the whole to be Divided into three-
Equal Parts between the said three My wife and two Children and do
appoint my wife Elizabeth Goddard and my Brother Francis Goddard
to be my Executors and do hereby revoke all other former Wills and
acknowledge this to be my Last Will and Testament In Witness whereof
I have set my hand and Seal this Second day of January in the Year
of our Lord 1759 Signed Sealed and Acknowledged in Presence of
