Whereas I have made use of eight hundred pounds current Money
belonging to my daughter Mary being Part of the Legacy left her by her late
Uncle Peter Horry deceased, my Will is that she shall be paid the said Sum
of eight hundred pounds out of any Estate and to have her Equal share
of my Personal Estate with the rest of my children Item I give Full Power
and Authority to my hereafter named Executors & Executors to sell & dispose
of all or any part of my Personal Estate which is not hereingiven or
Bequeathed when ever they shall think Proper and the Monies arising
thereon to be put to Interest with Security for my children and to pay their
Shares to each of them as they shall attain their age to Inherit or day of
Marriage to wit my son Anthony and my three daughters Margaret Henrietta
Ashby Mary and Catherine Bonneau to them and their heirs forever
Item in Case my said Wife should have any more children by me after the
signing of these presents that then the child or children so born shall have
its equal portion with the rest of my above children Item I do hereby
Nominate and Appoint my said Loving Wife Margaret Henrietta Bonneau
of this my last will and Testament so long as she shall continue my Widow
and no longer and my Brother Benjamin Bonneau my two brothers in

Memory but considering the uncertainty of this life and knowing that it

God who gave it and my body to the earth from whence it was made to be
Buried in a decent Christian manner at the disposal of my Executors
whose Names shall be after mentioned not doubting but at the general
Resurrection I shall receive the same do therefore make and Ordain this
my last Will and Testament that is to say first of all it is my Will & Pleasure
that all my Real and Personal Estate should be sold at publick Sale
within two Months after my death Secondly that all my Just & Lawful
Debts together with my funeral Charges be discharged and Paid as soon
as is possible thirdly I desire that what Remains of my Real and Personal
Estate should be put out at Interest and be paid to my Children as shall
be after mentioned It is my Will and Pleasure that my two Sons by Name
Samuel Eaton & Jeremiah Eaton should be bound out Apprentices until
they come and arrive at the Age and Ages of Twenty one years, it is my
Will and Pleasure my three Son start for away, Samuel & Jeremiah
Eaton should share and share alike equally in a Part of both my real &
Personal Estate and that they should have their Part & Parts at the Age of
Twenty one years but in case any one or more of my said Sons should
die before they come of Age then let his or their Part and Parts be equally
divided amongst all my Children that shall be then alive Item it is my
Will and Pleasure that my Daughter Sarah Eaton should share Twenty five or
more of my Real and Personal Estate than my Sons shall share It is my
Will and Pleasure that my daughter Lydia Eaton should share thirty
Pounds more of my Real and Personal Estate than my Sons shall share
it is my Will and Pleasure that my two daughters Sarah and Lydia
Eaton should Receive their Part and Parts of my whole Estate each
of them at the Age and Ages of Seventeen years but in case either of my
Daughters or both of them should dye before they come to the Age of
Seventeen years then it is my Will and Pleasure that their part and Parts
shall be equally divided between all my Children that shall be then alive
Lastly I do hereby Appoint Ordain & constitute my Loving Friends John
Calder Joshua Eaton and Benjamin Seabrook Executors of this my last
Will and Testament hereby utterly disallowing and Revoking all former
Wills by me made In Witnes whereof I have hereunto set my hand &
Seal this fifteenth day of March in the year of Our Lord One thousand
Seven hundred and fifty Seven and in the thirtieth year of his Majestys

Reign.
