the province of South Carolina Plaintiff being weak and in a low Condition but
in good sound and disposing mind, merrily blessed be God for the same do make and
Ordain this my last will and Testament in manner and form following. First
and principally I commend my soul into the hand of almighty God, hoping
thro the satisfaction and merits of my only Saviour and Dear Redeemer Jesus
Christ to have full and free pardon of all my sins and to inherit Eternal life, my
Body I commit to the Earth to be decently Buried at the Discretion of my Executors
here after named and touching such Temporall Estate as it hath pleased God of his
Infinite mercy to bless me with I give and dispose thereof as followeth. Imprimis
I will that all my Just Debts and Funerall Charges and Expences be first paid
and discharged Item I give and Bequeath unto my Daughter Elizabeth the sum
of One hundred Sterling to her and her Heirs for ever Item I give and
Bequeath unto my Three Grand Children to wit my Grand Son Josias, &
Grand Daughters Mary & Susannah Borneau the sum of Fifty pounds to
Each of them of good & Lawfull money of South Carolina to be paid unto my
said Grand Children at the Ages of Twenty one years or day of Marriage

84) That is to say my grandson to receive his share or part at the age of Twenty one Years and my granddaughters to receive their shares or parts at the age of Twenty one years or day of Marriage. Item my will is that if any of my aforesaid grand Children should die before they were of age to receive their share or part then then my will is that the share or part of him she or them so dying shall return to the survivors or survivor of my said grand Children to be he or them and their heirs forever, But if it should so happen that all my above said grand Children should die before they come to receive their Shares or parts, then my will is that their parts or shares shall return to my four children to wit my sons Peter, John & James Dubois & my Daughter Frances Rochet to be Equally Divided and shared between them to them and their heirs forever. Item I give and Bequeath all the rest of my Estate of what kind soever to be Equally Divided and shared between my four Children to wit my sons Peter John and James Dubois and my Daughter Frances Rochet to them and to their heirs forever. Item and I do hereby Nominate, Constitute and appoint my sons Peter and John Dubois & son in law Peter Rochet Executors to this my last will and Testament hereby revoking Making Null and void all former and other will or wills by me heretofore made and this to be and stand as and for my last will & Testament In Witness whereof I the said Susanna Dubois have to this my last will and Testament set my hand & seal this 19th day of July in the year of our Lord One thousand seven hundred and Eighty seven.
