taments In manner & form following and Expect & Require that it should
be named and allowed by all as such, And to that End do hereby revoke
annul and make utterly Void all former Testament or Testaments Wills
and Wills whatsoever by me heretofore made or Declared And first Humbly
Commend my Soul to Keeping of almighty God Trusting through his bountiful
Declaration of Grace and Mercy to Mankind to be pardoned & Accepted by the
Merits of Jesus Christ my Saviour my Body I Commit to the dust from which
I know it must return never the less Expecting a Joyfull reunion of Soul
and body at the Resurrection of the Dead Hereto to the Temporal Estate you
have been Pleas'd to bestow on me with I dispose of it in manner & form follow-
ing that is to say I Impresc I will and Ordain that all my just debts
whatsoever shall be well and punctually Paid and discharged 2^{dly} I
will that the remainder of my Estate be sold and that the money be Equally
Divided amongst Jean Affleck & my Mother my two Brothers George &
Andrew Affleck & my two Sisters Jean & Magdalen Affleck of Dunbar in
Scotland In case of the Death of any of them their Heirs or their Parts to
be Equally Divided amongst the mentioned Survivors Lastly I do hereby
nominate constitute ordain and Appoint my Good Friend John Edwan
& Edward Jones Merchants of Charles Town my Sole Executors of
this my Last Will and Testament In Witness whereof I hereunto Set
my hand and Seal the Eighteen day of January in the Thirty Second
Year of the Reign of our Sovereign Lord George the Second of Great
Britain France & Ireland King Defender of the Faith Anno Domini 1762

Testament in Writing bearing date the eighteenth day of January 1750
The said Thomas Affleck by this Present do Ratify and Confirm my
Last will & Testament & do Give & bequeath before my Estate be divided
my Loving Aunt Magdalen Board Twenty Pound Sterling & also to my
friend Thomas Ballantine four Guineas to be paid them by my Executors
And my Meaning is that this Codicil be adjudged to be a part of my Last
Will and Testament and that all things therein mentioned be faithfully and
truly performed as fully in every respect as if the same were so declared & set
down in my Last Will & Testament Witness my hand this Sixth day of Feb^r
1758

This will & Codicil was proved and at the same Time John Edwards qualified as Executor

& Chairs four head of horses and mares one Mahogany Table one Negro Man
named Joe one Negro woman named Bess and one Negro Girl named
Hannah as also one Desk one Bedstead Bed and furniture one Bedding
Trunk one Cyprus Table one Poplar Table one Tea Kettle three Boxes &
two Cows & Calves to hold the same to her and her heirs for ever
Item I Give and bequeath to my Son Herbert Hodson one horse a bull and
one Mare called Rose to him and his heirs for ever Item I Give and
bequeath to my daughter Sarah Hodson one Negro Woman named Dot
with two cows & Calves and one feather Bed and furniture to hold the same
to her and her heirs for ever Item I Give and bequeath to my Son Thomas
Hodson all and every the remaining part of my Estate both real & perso-
nal wheresoever it may be found to him and his heirs for ever he
said Thomas Hodson allowing out of the same the sum of One
hundred and fifty Pound current Money of South Carolina to be paid
to my daughter Mary Hodson when she may Arrive to the of Twenty
years if demanded and it is my farther will that my wife Mary Hodson
may have the Liberty of Living on my Said Plantation untill such time
as my Son Thomas shall Arrive to the age of Twenty one years Item
It is my will that all my Estate may be disposed of after the Manner
as I heretofore mentioned and that there be no Publick Sale made thereof
and that my Son Thomas Hodson and my friend Robert Wood to be my true
and Lawfull Executors of this my Last Will and Testament before
revoking and disannulling all other wills and Testaments by me made
