And in case they should die before age, or hearing any lawful issue I will that all my Estate shall be given to Richard Rendarris's Son of Irish Rendarris and I hereby nominate and appoint my Executors Friends Irish Rendarris and Robert Wallingall whole and sole Executors of this my last Will and Testament hereby revoking all former and other Will and Testaments by me heretofore made declaring this only to be my last Will and Testament in Witnes whereof I hereunto set my hand and seal the 20th day of February one thousand seven hundred and Eighty nine

In the Name of God Amen I Benjamin Perdrigue of the Parish of St James's Barren County and Province of South Carolina being very well and of sound mind and memory do make & ordain this my last Will and Testament first recommending my soul into the hands of Almighty God and my body to be decently buried at the discretion of my Executors and as to all my worldly affairs I give and bequeath in the manner and form following (that is to say) Item my will is that all my lawful and reasonable debts and general expenses be justly paid from my Estate by my Executor and Executors hereafter named Item I give

unto

unto my son Benjamin Perdrigue a Negroe boy named Lewis and also all my lands excepting one third part of the said lands which my dear Wife Mary Perdrigue shall choose to live upon during her Widowship and no longer and then it shall be all his own Item I give unto my daughter Elizabeth Marrow five Shillings Sterling after my death and no more Item I give unto my daughter Hynd Perdrigue five Shillings Sterling after my death and no more Item my will is that my Wife Mary Perdrigue shall have liberty to choose either a horse or a Mare out of my stock Horses for herself and her saddle and bridle and also all her wearing apparel and her bed and furniture Item also my will is that all the Neats Cattle that did belong to my son Joseph Perdrigue which was given to him by his God father and none by my year Mark and his brand which is three 3 put on them shall be equally divided betwixt my four children which are here named Mary Perdrigue and Peter Perdrigue and Thomas Perdrigue and Sarah Perdrigue Equally share and share alike Item my will is that after these legacies and reasonable debts be paid the rest of my Estate shall be Equally divided betwixt my wife and her children begotten by me which is Mary Perdrigue and Peter Perdrigue and Thomas Perdrigue and Sarah Perdrigue Equally share and share alike and I do hereby nominate and appoint my dear loving wife Mary Perdrigue to be my Executor of this Country and my son Benjamin Perdrigue to be my Executor of this my last Will and Testament given under my hand this thirtieth day of October one thousand seven hundred and Eighty nine. Note that the word or name of my son Thomas is underlined betwixt the line Twenty Eight and Twenty nine which shall stand good in law Signed sealed and Declared by the
