 Air two layed Worked Silks my six gold & diamond Rings with my
 Buttons & Buckles two silver table spoons marked WA one other
 silver table spoon marked WA one other MA and another marked FA
 I do desire that my Executors hereafter named will part & divide the
 same between my said children. Item my will is & I do hereby order
 direct & empower my Executors hereafter named & the survivors of
 them for to sell & dispose of the whole or any part of the Resid-
 ues & Remainder of my Estate either Real or Personal as soon as
 conveniently may be after my decease & that the moneys arising therefrom be
 equally divided between my two sons William & James Air when they
 shall attain their ages of twenty one years. Item I desire that the
 moneys coming to my said children out of the sale of my Estate as above
 may be placed out at Interest or Good personal Security in this
 Province so that the same may be otherwise employed by my said
 Executors as they shall think well be much for the advantage & benefit
 of my said children. And for the better Education of my Sons I do
 give & dispose of the tuition & Custody of them & the survivor of
 them unto my said Executors until they shall attain their ages of
 twenty one years And my will further is that the whole or any part
 of the moneys arising from the sale of my Estate as aforesaid shall or
 may be employed at the discretion of my Executors either in the main-
 tenance, Education or placing out my said children apprentices And
 in case of the death of my said children they I give & devise all
 such sums of money as shall arise by the sale of my Real & personal
 Estate as aforesaid unto my two Brothers Lewis & William Adams or
 to my Sister Mary Brooks to be equally divided between them
 And I do hereby empower my said Executors by these presents for
 which they shall think proper to do & each from time to time in
 about or concerning the premises And if any Error or losses
 shall

shall happen or if any bad debts are made they shall not be accountable for the
 same and Justly I do hereby ordain constitute and appoint my good friends John
 Savage & Henry Lawrence of Charles Town Merchants & the survivors of them
 Executors of this my last Will and Testament & do hereby revoke & make void
 all former & other wills by me at any time heretofore made declaring this
 only to be my last Will & Testament In Witness whereof I have & this
 my last Will & Testament set my hand & seal this twenty sixth day
 of September in the year of our Lord one thousand seven hundred and
 sixty three
