I James Bagby of the Parish of Saint Stephen in the
County of Beaufort Carolina Planter being sick & weak in
Body but of sound & disposing mind memory & understanding
blessed be God for the same do make publish & Declare this to
be & contain my last Will & Testament in manner of form
following First principally when it shall please God to call me
hence I resign my soul unto the hands almighty Protection
hoping for the remission of my sins Thro' the merits of my
Saviour Jesus Christ & my Body I Commit to the Earth to be
decently Buried at the Discretion of my Exors hereinafter
naming as to what worldly Estate it hath pleased God to
bestow upon me I hereby give Devise & Bequeath the
same as follows viz: In the first place I do give & bequeath
unto Jane Davis of the Parish of Saint Stephen aforesaid the
five Negro Slaves hereinafter named to Wm London & Wm
his wife & Johnny & Becky their children their Children & the
Negro Maids Eliza To have & to hold the same to the said
Jane Davis her Heirs Exors assigns forever
Item it is my Will & Desire that my Exors herein
after named do keep all the rest residue of my Estate
together for the Space of Term of five Year after my Decease
& the yearly Profits & Income thereof After paying necessary
Charges & Expenses I hereby order & direct Shall be applied
towards Satisfaction of my just & lawful debts & the surplus to
be put out at Interest by my Executors for the use & benefit
of the legatees as hereinafter mentioned Item it is my
Will that the said Jane Davis have leave to live & reside on

my Plantation in Saint Stephen Parish During the said Term
 of Five Years **Item** That after the Expiration of the said
 Term of Five Years or Sooner if my Executors shall find it more
 for the Interest & Benefit of the Legacies of This my Will in order
 that the residue of my Estate (after taking out the five Negroes be
 for particularly Bequeathed) may be the more easily & equally
 Divided between & among the Legatees in such manner
 as is hereinafter mentioned it is my Will & I hereby order &
 Direct that such residue of my Estate as will real as per-
 sonal be sold by the Executors hereinafter named or such of
 them as shall take upon them the Execution of This my
 Will them I hereby authorize & empower to sell & Dispose of the
 same either at publick or private Sale as they shall see fit
 & to make & Execute such sufficient Conveyances or Conveyances
 to the purchaser or purchasers as Counsel Learned in the Law
 shall advise **Item** Whereas I have uncles & Nephews on the part
 of my Father that may be alive & there may be Children of
 some of my Father Brothers or Sisters who are Deceased that
 represent their parents whose Names I know not & who I would
 be willing should Enjoy their Father or mothers part of this my
 Estate in the same manner as is particularly devised to the
 Father or mother by name, It is my will therefore and I
 hereby order and direct that after the Residue of my said
 Estate is sold by my Executors as aforesaid and the moneys
 received by them for the same, That they my said Executors or
 such of them as shall take upon them the Execution and
 Execution of this my Will Do pay to and divide equally
 among my uncles and Nephews on the part of my Father
 that are alive, and the Children of such of my Fathers, Brothers,
 & Sisters as may be Dead (the Children to take per capita and
 not per stirpes) the monies arising from the Sale of the Residue
 of my Estate real & personal as aforesaid, and such Division
 to be made among them by my Executors in the same
 manner as personal Estates by the Statute of the Twenty second &
 Twenty third Charles the Second, are directed to be Distributed
 among the nearest in kin to an Intestate in equal Degrees and
 their Representatives after deducting the legacies hereinafter
 given and bequeathed to Rachel Davis as after mentioned.
 Provided my said Uncles, Nephews & Cousins or some of them
 do appear with or transmit unto my said Executors sufficient
 Testimonials of their Propinquity and Relation with power &
 authority to receive the Legacies hereby given and bequeathed
 unto them within five years after my Decease. **Item** it
 is my Will and I hereby order & direct that my Executors hereinafter
 named or such of them as shall take upon them the Execution
 and Execution of this my Will, Do give notice in one or both
 of the Gazettes published in Charles Town at least sixteen times
 in every year during the space of five years after my Decease
 desiring that my Uncles & Nephews and their Children or some of
 them, do either appear with or transmit unto my said Executors
 sufficient Testimonials of their Propinquity and Relation to me

with power and authority to receive in their behalf the legacies
 hereby given and bequeathed to them as aforesaid.
 Item In case my Uncles Aunts or their Children or any of
 them do appear or by attorney make proper claim to the Estate
 hereby given unto them in the said space or Term of Five years after
 my Decease, and shall be entitled to the Residue of my said
 Estate in the manner hereinbefore mentioned, I hereby order
 and Direct; that before the Delivery of the same to them or
 either of them my said Exors in the first place, do pay or
 cause to be paid unto Rachel Davis Daughter of David Davis
 or to her Exors Adms or Assigns the sum of three hundred
 pounds current money. Item In case my said Uncle
 Aunts or their Children or some of them do not appear with
 or transmit unto my Exors sufficient Testimonials of their
 Popinquity and Relation within the said space and Term
 of Five years after my Decease; That then it is my Will
 that my said Executors and the Survivor of them or such of
 them as shall take upon them the Execution of this my Will
 do pay to and equally divide the moneys arising from the Sale
 of the Residue of my real and personal Estate herein before
 mentioned among the six persons here after named, to wit
 William Davis, Benjamin Davis, Henry Davis, Rachel Davis
 Daughter of the said David Davis, and William Davis son
 of the said William Davis, to them their Exors, Adms and
 assigns for ever share and share alike. And lastly I do
 hereby nominate constitute and appoint my friends David Davis
 William Jamieson & Theodore Gourdin Executors of this my Will
 Revoking hereby making Void and Null all other Wills by
 me heretofore made. In Witness whereof I have to this
 my Will, set my hand & seal this Twelfth Day of January In
 the year of our Lord one thousand seven hundred and sixty six
