In the name of God amen This 15 day of May 1758 I John Rues of the parish of St Thomas in Berkeley County in the Province of South Carolina Planter being in perfect health Thanks be to God therefore calling to mind the mortality of my body and knowing that it is for all men once to die do make & ordain this my last Will & Testament in manner & form following that is to say Principally & first of all I give & recommend my Soul into the hands of Almighty God that gave it and my body I recommend it to the earth to be buried in Christian manner at the discretion of my wife and Executors nothing doubting but at the general Resurrection I shall receive the same again by the mighty power of God & as touching such worldly Estate wherewith it hath pleased God to bless me with in this life I Give bequeath and dispose of the same as follows First my will and desire is that all my just & lawful debts be paid & discharged Item I give and bequeath unto my wife Mary one half of my Estate Item I do give and bequeath unto Abijah Rues & Robert Daniel Jun^r the other half of my Estate to be equally divided between them And at my Wifes death that her halfe shall return unto the said Abijah Rues & Robert Daniel Jun^r abovenamed to them & their heirs forever Lastly I do hereby nominate constitute & appoint my trusty friend Robert Daniel to be my lawful Executor

 Rucy Tom Libria, Greenwich Hannah, Mingo Sarai, Country born ~~Caro~~ Caro
 Ling, Mindon little Ben, Ned Phoebe, Anthony & Simon with the issues
 of the said Bellow Lady, Lilrig Rucy Hannah Sarai, Mindon & Phoebe
 which they may have & all my household Goods, Tools & implements and
 utensils of Husbandry & two thirds of the Stock of Cattle which are at the
 plantation where he now lives & which I lately sold to Samuel Thomas
 Esq. & also one bed and furniture & one mattress and furniture, my
 writing desk, large table & six new black chairs which are at my
 dwelling house & one case of bottles which contains nine gallons & also one
 of my canoes. Item I give & bequeath unto my Daughter
