And I do hereby empower my said Executors and the survivors and survivor of them to sell and dispose of any or all of my Negroes or to buy others with the profits of my estate and to employ them either in the clearing and planting of land cutting of wood or sawing of timber. Item my will is and I do hereby order and direct that as my sons attain their respective ages of twenty one years they shall be entitled to have and receive an equal part of my personal estate and I further will that my daughters shall also be entitled to have and receive an equal part of my personal estate with my sons as soon as my said daughters shall have attained their respective ages of twenty one years or day of marriage which shall first happen from my will is and I do hereby order and direct that my Executors and the survivors and survivor of them shall when they see fit bargain sell and alien in fee simple all my real estate not heresaid mentioned for the doing Executing and perfect finishing whereof I do by these presents Grant will and transfer to my Executors and the survivors and survivor of them full power and authority to grant, alien bargain sell, convey and assure all my real estate to any person or persons and to their heirs forever, and further more that the money arising therefrom shall be equally divided amongst and between my sons and daughters and in case any of my children should should happen to depart this life before they attain their ages of twenty one years or day of marriage as above said then I will and I do hereby order and direct that such child part or share, shall go to and be equally divided between and amongst the survivors and survivor of my said children and to their heirs and assigns forever. And I do hereby indemnify my said Executors and the survivors and survivor of them by these presents for what they or any of them shall think proper to do and each from time to time in and about or concerning the premises and if any error or loss shall happen or if any bad debts are made they shall not be accountable for the same and my will is and

and I do hereby nominate and appoint and by these presents do nominate and appoint my Executors heresaid named and the survivors and survivor of them to be guardians of the persons and Estate of my said children until they shall attain their respective ages of twenty one years or days of marriage. And lastly I do hereby ordain constitute and appoint my loving brother Chas Vanderhorst of Charles Town, merchant and my good friend William Ellis, John Moore and Henry Bonneau and the survivors and survivor of them to be executors of this my last will and Testament. And I do hereby revoke and make void all former and other wills by me at any time heretofore made declaring this only to be my last will and Testament. In Witness whereof I have to this my last will and Testament set my hand and seal this Twenty fifth day of January in the year of our Lord one thousand seven hundred and sixty four.

 Executor and my loving mother M^{rs} Elizabeth Bowrey Executrix
 of this my last will and Testament and I do hereby revoke re-
 vocation and make void all former wills and Testaments by me
 heretofore made and do declare and appoint this to be my last will and
