of Colleton County in the province of S^c Carolina, being
in good health & perfect & Sound Mind & Memory, but
calling to mind the uncertainty of life Do make &
Ordain my last will & testament in manner & form
following that is to say first & principally, my soul I resign
into the hand of Almighty God who gave it & my body to
the earth to be decently buried at the discretion of my executors
hereafter named in hopes of a happy resurrection by the Al-
mighty power of God, at the last day to Eternal Life, through
the only Merits of my lord & Saviour Jesus Christ & as touch-
ing those things it has pleased God to Endow me with
I give & dispose of in manner & form following

Imprimis, I will that all my just debts & funeral
charges be first paid & satisfied, Item I give & bequeath
unto my loving wife Susannah Jordan Two Negro Girls
named Clarissa & Pegg, with my best Chair horse, riding
Chair & harness, And one equal third part of my moveable
Estate, after all my debts are paid & her right of living on
my ~~estate~~ settled Plantation during her widowhood to me
or living my Widow & no longer. Item I give & bequeath
unto my Daughter Mary wife of Mr George Timmons
of Georgia, One Negroe Girl named Pamela which
I have lent her for the present. Item I give be-
queath & demise, unto my two sons, James & William
Jordan all my lands & real Estate wherever or howsoever
to be equally divided between them share & share alike &
to their heirs forever, & the remaining two equal parts of my
moveable estate which they are to divide with my wife

Share & share alike & to their heirs for ever, Lastly I constitute & appoint
my Good friends the Pres^t W^m Simpson, James Hamilton & James
Donnan Esq^s & my son James Jordan, Executors to this my last will
& testament & Guardians to my Sons & hereby disannul & disavow
all other wills & bequest by me before made allowing & confirming
this only to be my last will & testament dated the 29th March 1774

In the name of God Amen I Samuel Grier
of Craven County in the province of So Carolina Planter being in
good bodily health & of Sound & disposing Mind do make & Or-
dain this to be my last will & testament resigning my soul to
God & desiring that after my decease my body may be decently
Interred by my Executrix & Executors herein after named & with the
Respect to the worldly Estate of which I may die possessed, I
will as follows, In the first place, I order that my whole Estate
wheresoever & whatsoever be kept together & improved untill all my
Just debts shall be paid, after which I give unto my Son John
Grier the Six following Negroes viz Ben, Bob, Glasgow, Lydia
Libia & Nero, Also one fourth part of my Negro Slaves not par-
ticularly named in this my will One third part of my house-
hold Goods & Kitchen Utensils, my riding horse & watch & one half
of my Stock of Cattle Horses Hogs & Sheep, I also give devise &
bequeath unto my said Son John & to his heirs & assigns for ever
Two thirds of that any Plantation or four tracts of Land, situate
on Great Cedar River whereon I now reside containing in the
whole nineteen hundred & fifty acres of Land more or less to be
divided as is herein after directed, also all that my plantation
