I give & bequeath to my dear wife Hannah White One hundred
pounds & to my Niece Sarah White of George Town daughter of my

Executrix herein after named in twelve Months after my decease
Thirdly I give & bequeath to Joseph Lefevre son of Peter Lefevre
of George town my Negroe woman Silvia & her son Marcus with
the future Issue & increase of the said Negroe Woman to be
delivered to him at the Death of my wife Anna White, but in
case the Joseph Lefevre should die before he is intitled to re-
ceive & possess the said Negroe Woman Silvia & her son Marcus
with the future Issue & increase of the said Negroe Woman then
in such case the said Woman Silvia her son Marcus & the future
Issue & increase of the said ^{Negroe} Woman shall be possessed & enjoyed, by
all the Children then living of the said Peter Lefevre & Mary
his wife to be divided between them share & share alike, fourthly
I give & bequeath to my dear wife Anna White all the rest &
residue of my Estate of what nature or kind so ever it may
Consist, Lastly I do hereby nominate & appoint my said wife
Anna White sole Executrix of this my Will, hereby revoking &
Annulling all other & former Wills by me heretofore made in
witness whereof I have hereunto set my hand & Seal this thir-
teenth day of March in the year of our Lord One thousand
Seven hundred & Seventy two
