

In the Name of God, Amen, I Mary Trissel of the Parish of Christ Church in North Carolina being informed in Body but blessed be God, of sound and disposing mind and memory do make and Ordain this my last Will and Testament in manner and form following that is to say, Principally I commend my immortal spirit into the hands of God who gave it in and through Jesus my blessed Saviour and Redeemer, and my Body at Death I commit to the Grave to be buried in a decent Christian manner at the Discretion of my Executors herein after named and as to my worldly Estate Goods and Chats as it hath Pleased God to bestow upon me, in this life I will and desire that the same and every part and parcel thereof shall go and be disposed of as is hereafter respectively mentioned. I Give and bequeath unto Joseph my firstborn Children Joseph and Elizabeth Traxer fifty pounds currency to be paid to each of them at the age of twenty one years by my Executors. I Give and bequeath unto my Grand Daughter Mary broff Daughter to a Mathew broff one Negro Girl named Sally, five Tea Spoons one leather Bed and furniture. And my wearing Apparel and the sum of fifty Pounds currency to her, her being and Assigns for ever at the age of sixteen years. I Give and bequeath unto my Daughter Mary broff the sum of ten Pounds currency to be paid at my Death in lieu full Accomplece Interest and Demands whatsover. I Give and bequeath unto a Martha Mary White Daughter unto Samuel White the sum of fifty pounds currency to be paid unto her Father Samuel White at my Death. I Give and bequeath unto my two Grand children Susanah broff and a Mathew broff, Son and Daughter to Mathew broff, the Residue of my Estate to be sold and put at Interest and to be equally divided between my two above named Grand children and in either of my Grand children should die before they come to the Age of Twenty One years or the day of Marriage that then my Estate shall be equally divided between my surviving Grand children. I Nominate constitute and appoint George Thompson John Russell Sen. and Samuel White Executors of this my last Will and Testament. And Lastly I hereby revoke and annul all former and other Wills Testaments by me heretofore made or declared and do confirm and allow of this my said last Will and Testament set my hand and seal the first day of May, one thousand seven hundred and seventy.
