the Merits and Mediation Jesus Christ my Saviour and Redeemer and my
Body I commit to the Earth to be buried in a decent and Christian Lik man-
ner at the Discretion of my Executors here in after mentioned and concern-
ing the Temporal Estate where with I hath please God to Bless me with
I Will and ordain that the same and every part and Parcel thereof shall be
disposed of in manner and form Following that is to say I Will order and
Appoint that all my Just Debts and Funeral Expenses be discharged and
Paid as soon as convenient it may be done after my decease. Item I give
and Bequeath unto my dear Brother Jonathan Fabian the Plantation
or Tract of Land whereon I now live at Fort Mifflin also Ten Negroes boys
commonly known by the Names of Kitt and Stephy and also a Bond that
I have against Capt John North the above Premises to him and his Heirs
and Assigns for ever more - My Will also is that the nine Following
Negroes Viz Harry King, Primus Rose and Child Hager Begg Jada with
with her youngest Child and Household Furniture and Stock of Horse
Cattle and Hogs to be sold by my Executors hereafter mentioned at pub-
lick Vendue and all the money arising of the Sale of the above nine
Negroes Stock of Horse Cattle and Hogs to be Equally divided
between my loving Brothers James Fabian Joseph Fabian and Jonathan
Fabian to them and their Heirs and Assigns for ever -

I give and Bequeath unto my Loving Son the Page a Negro Girl commonly known by the name of Metic the eldest Daughter of a Mench called and known by the Name of Jada as long as this Page shall live and after Death to my Dear Brother Joseph Fabian of record to him and his Heirs for ever - My will also is that all my Plantation Tools &c. should be sold at Public Vendue and the Money arising to be Equally divided between all my Brothers to them and their Heirs for ever. - My Will is also that an old Fellow called and known by the Name of August and old Mench called and known by the Name of Metic should at my Death have their Freedom Lastly I do hereby Nominate Constitute and appoint my said Loving Brothers James Fabian Joseph Fabian and Jonathan Fabian Executors of this my last Will and Testament hereby revoking and making Null and Void all and all manner of former and other Will or Wills by me at any Time or Times heretofore made hereby declaring this on by to be my last Will and Testament. In Witness Whereof I the said William Fabian to this my last Will and Testament have here unto set my hand and Seal the Twentieth fifth day of February in the Year of our Lord one thousand seven Hundred and Sixty five.
