17 A^d State of South Carolina. In the Name of God.
 N^o 6 I William Henry Draughton do make and constitute
 this to be my Last Will and testament in manner & form
 following Viz: I give and bequeath my yellow woman Harri-
 et and her two youngest children Patty and Sia and Toney
 and Gary (the son & Daughter of Hinch) & alsoe the daugh-
 ter of Mary and their future issue and increase to my un-
 cle Thomas Wilson in trust for a free woman named Eliza
 McKee or Eliza Defts to her and her representatives forever,
 and I also give and bequeath to the aforesaid Thomas Wilson
 in trust for the said Eliza all my furniture including
 pictures but not Books to her and her representatives for-
 ever. And I do further order and Will that the said Thom-
 as my executor hereinafter appointed shall pay or cause to
 be paid to the said Eliza an annuity of two hundred Dollars
 in quarterly payments of fifty dollars during her Life of
 course. Item I give and bequeath a boy called Charles the
 son of Rose and my faithful domestic Pedro to my Cousin
 Martha Wilson in trust for the uses and purposes that will
 be declared and made known to her by my uncle the said
 Thomas all which she will execute and carry into effect at
 an early a day as possible. Item all the rest and residue
 of my estate & Interest of Whatever nature it may consist
 I devise give and bequeath to my aunt Sarah Wilson in
 trust, but in the event of her death to my cousins Martha
 and anne Wilson for the uses intents and purposes herein-
 after expressed, that is to say in trust for my uncle the
 aforesaid Thomas Wilson who as my executor shall be imme-
 diately empowered to take possession of my estate aforesaid
 and have the sole and entire management and Control there-
 of and after having defrayed the annual expences to ap-
 propriate the remainder of the profits to his maintenance
 and Support in Satisfaction of all Services rendered, and

should maintenance not require all the profits then Surplus to be carried to the improvement & increase of my estate. And whereas the aforesaid Thomas as my Executor & possibly the Executor of Father be frequently called from home, I leave him my Horses and Carouche that is the use of them, and it is my further Will that all the foregoing proper given and bequeathed in trust for the Management & use of my uncle the said Thomas shall be in no wise liable or Subject to the payment of his present or future debts and if he the aforesaid Thomas shall at any time withdraw or decline to continue in the manage the aforesaid Estate then or in the event of his death I give all the aforesaid Estate and Interest to my Aunt Sarah Wilson and her two Daughters my Cousins Martha and Anna Wilson and should they die without leaving issue living at their death then and in that case I give and bequeath all the aforesaid Estate to my Cousin Alfred Drayton and his heirs forever, and I do hereby expressly Will and order that should the said Thomas or my aunt or Martha or Anna in any way or manner whatever so use the profits of this estate as to conduce to the ease comfort or convenience of either of my Sisters or their Husbands or their Children that shall & by this my Will forfeit all right under the same. I do hereby nominate and appoint my uncle Thomas Wilson Executor to this my Last Will and testament done on the twenty ninth day of March in the year 1826
