## JOHN KIDD

In the Name of god amen; I John Kidd of fishing Creek Settlement County of Chester & State of South Carolina; being weak in Body but of perfict mind and memory; thanks be to god for it; and Calling to mind the mortality of my Body, and knowing that it is appointed for all men once to die; do make and ordain this my Last will and Testament; that is to Say; principally and first of all; I gave and Recommend my Soul to the Hands of god that; and my Body to be Buried at the Discretion of my Executors nothing doubting but at the general Resurrection I Shall Receive the Same again by the mighty power of god; and as tuching Such worldly Estate wherewith it has pleased god to Bless me in this Life. I give Devise and dispose of the Same in the following manner & form----first I gave & Bequeath to Jane my Dearly beloved wife one negro wench named Sall also one Sorrel Colt with band pare wiree years old last Spring also her Coice of two Cows & Calves from amonghat my Stock of Cattle as also her bedd & furnitur with her puter and two potts; She is also to have asufficient maintainance during her Life of the plantation I now live on at the Expense of my Son James Kidd and Should it be her Choice my Sd Son Jam Shall furnish her with areasonable decent house for her own use During her life --- I also gave & Bequeath to my Son John Kidd the two Hundred acres of land whereon he now lives being part of the tract of fourhundred acres that I now live on-I also gave and Bequeath to my daughter Mary Writeat the death of my Said wife dane; the negro winch

be to god for it; and Calling to mind the more Body, and knowing that it is appointed for all men die; do make and ordain this my Last will and Testament; that is to Say; principally and first of all; I gave and Recommend my Soul to the Hands of god that; and my Body to be Buried at the Discretion of my Executors nothing doubting but at the general Resurrection I Shall Receive the Same again by the mighty power of god; and as tuching Such worldly Estate wherewith it has pleased god to Bless me in this Life. I gave Devise and dispose of the Same in the following manner & form----first I gave & Bequeath to Jane my Dearly beloved wife one negro wench named Sall also one Sorrel Colt with franctimee years old last Spring also her Coice of two Cows & Calves from amonghst my Stock of Cattle as also her bedd & furnitur with her puter and two potts; She is also to have asufficient maintainance during her Life of the plantation I now live on at the Expense of my Son James Kidd and Should it be her Choice my Sd Son Jam Shall furnish her with areasonable decent House for her own use During her life -- I also gave & Bequeath to my Son John Kidd the two Hundred acres of land whereon he now lives being part of the tract of fourhundred acres that I now live on -- I also gave and Bequeath to my daughter Mary Writeat the death of my Said wife Jane; the negro winch Gallfirst mentiond also one yow & lamb; But Should my Sd Daughter Mary Write not live to poses the Said negro wench Sall; then I gave & Bequeath her to my grand Daughter Jane Write--- also gave & Bequeath to my Son Andrew Kidd two yows --- I also gave and Bequeath to my Daughter Mailha

I also gave and Bequeath to my Son James Kidd the tract of Land where on I now Live Containing two Hundred acres together with all the Remaining part of my Estate not already mentiond in this my last will, he is also to have the use of th Sd negro wench Sall in all throng times of work in the field when it is posible for my Said Wife to spair her; and Should the Sd negro wench Sall have any Increas Before the Beath of my Sd wife then my Sd Son Jam. Kidd is to have Sd Increas-and Lastly I do appoint my beloved wife Jane and my Son James together with Edwd Laccy to my Sole Executors of this my last will & testament -- and I utterly Revoke Disanul all former will & testaments by me made Ratifying and Confirming this & this only to be my Last will and testament -- In witness whereof I have hereunto Sett my hand and Seal this fourth Day of october onethousand Sevenhundred and ninety one; and of the Independance of the united States the Sixt nth---Signed Seald publisd and pronound in the presents of Jane Burd
