Dispose of the same in the following manner & form I Give and Bequeath to my three Grand Children the Children of my son William Sadler (Vis) Isaac Sadler Jane Sadler & Lettuce Sadler five shillings sterling Each Item I Give & bequeath to my Daughter in Law Mary Sadler the One half of the Upermost Tract of Land I Purchased from James Write Lying on turkey Creek to berun Through the said Tract Acrofs the said Turkey Creek Parrelllell with the Upermost Line of said Tract of Land Item I Give & bequeath to my Son Richard Sadler all & Every of my Land Except the Part Already Given to my Daughter in Law Mary Sadler In Consideration of one hundred and Sixty Pound fifteen Shillings Sterling To be Paid in four Gales Yearly after my Decease it is my will and I Order that the whole of the price of said Land After all Debts and Feneral Charges is Paid be Divided into two Eaqual Parts the one half to be Divided between my Son Richard Sadler & my Daughter in Law Mary Sadler & the other half to be Divided Eaqually between Jane Sadler Belrige Rogers Mary Love & Agnefs Glen And I do hereby make & Ordain Constitute & Ap-point my Sons Richard Sadler & Clayton Rogers Executors of this my Last Will Intrust for the Intent & Purpose in this my Will

Intent & meaning and I do hereby Utterly Revoke and Disannull
all former Wills & Testaments Ratifying & Confirming this and
no Other to be My Last Will & testament In Witnefs whereof I
