stitute this my last Will & Testament in manner and form follow-
ing wh I recommend my body to be buried and bestow my worldly
Goods I lend my beloved wife the plantation whereon I now live
during her natural Life as follows I lend my beloved wife Mary
all my Negroes during her Natural life I also lend my wife
Mary all my Stock of Horses Cattle Sheep and Hogs during her
natural life I also lend my wife Mary all my money in hand &
money to Collect during her Natural life I give and bequeath
unto Thomas Hughs the Land whereon he now lives bounded on
Charles Nixes Land thence to the Creek thence down the creek
till it comes against Nixes corner again to him and his Horses
for ever un
I give and bequeath to my son Thomas Hughs two Negroes
Namely Jan & Bob to him and his Heirs for ever I give and
bequeath unto my son Isaac Hughs the lands joining Thomas Hughs
on the other Side of the creek thence up the creek to the upper
corner thence to Davies upper corner thence to/ creek again to
where the forth line crosses to him & his Heirs for Ever I
give and bequeath unto my son Isaac one Negroe Named agness
to him and his heirs for ever I give and bequeath unto my Son
John Hughs the land where, his improvement is runing down the
River to the first branch thence up the branch to the North line
thence along the North line to the river again to him and his
heirs for ever I give and bequeath/ un to my Son John one Negroe

I give and bequeath to my son Thomas Hughes two Negroes Namely Nan & Felle to him and his Heirs for Ever I give and bequeath unto my son Isaac Hughes the lands joining Thomas Hughes on the other Side of the creek thence up the creek to the upper corner thence to Davies upper corner thence to/ creek again to where the North line crosses to him & his Heirs for Ever I give and bequeath unto my son Isaac one Negroe Named agness to him and his heirs for Ever I give and bequeath unto my Son John Hughes the land where, his improvement is runing down the river to the first branch thence up the branch to the North line thence along the North line to the river again to him and his heirs for Ever I give and bequeath/ un to my Son John one Negroe Esther to him and his heirs for Ever I give and bequeath unto my Son William Hughes the land below Johns runing down the river to the Spring Branch up the Spring branch to Isaac line thence along Isaac line to Davis, corner thence along Johnes line to the river again to him and his heirs for ever I give and bequeath unto William Hughes one Negroe Named Toe to him and

his heirs for Ever I give and bequeath unto my Son Andrew Hughes the Land runing up the Lick Branch to the North line thence along the North line to Thomas Hughes line thence along Thomas line to the Creek thence down the creek to the begining to him and his Heirs for Ever I devise give and bequeath unto Andrew Hughes one Negroe Named Jane to him & his heirs for ever I give and bequeath unto my Son Peter Hughes the Plantation whereon I now live being a remainder after the rest of his Brothers lands now mentioned to him and his heirs for ever I give and bequeath unto Peter Hughes two Negroes Hanna rachel with the Increase of Rachel to him and his heirs for ever my desire is that my Executors sell the three hundred Acres of Land that I have on Rockey creek and the money to be equally divided amongst my Six Sons I give and bequeath unto my Daughter Mary Thomas five Shillings to her and her heirs for ever I give and bequeath unto my Daughter Lydda Johns five Shillings to her and her heirs for ever I give and bequeath unto Gary Larten my daughter one Negroe Named Abram to her & her heirs for ever I give and bequeath unto my daughter Rebecka Larten one Negroe Named Moses to her & her heirs for ever My desire is if any of my afore mentioned Sons should dye Without heir lawfully begotten the property I leave them to be equally divided Among the rest I desire that my Sons Thomas Andrew & William Hughes be my Executors
