In the name of God Amen. this Seventeenth of December
 eight hundred and two I George Cannon of Darlington
 district and State of South Carolina being in mind and
 Memory Thanks be given to God therefore Calling to mind
 the mortality Of my body and Knowing that it is appointed
 for all men once to die. I. do. make and Ordain This my
 last will will and Testament in manner and form following
 that is to say first of all. I give my soul into the hands of
 God that gave it me not doubting that at the General Resur-
 rection I shall Receive the same again and my body to the
 Ground to be buried in a Christian and decent manner at the
 discretion of my Executors hereafter named and as for what
 worldly estate it hath pleased God to ble's me with I give
 demise & dispose in manner and form following--Imprimis--
 I give and bequeath unto my beloved. wife. Susannah. Cannon
 my house and one third of the Creek Tract of Land and one
 third of the back Tract of Land During her Life time. Also.
 one Negro man by the name of Uny. during her widowhood.
 or life time at the discretion of my Executors. Item--
 Give and bequeath unto my beloved Wife. one bed and furniture.
 the bed that come by her four Cows and Calves. one horse brid
 saddle horse Galed buck and Half the Kitchen furniture and all
 the Crockeryware one third part of my hogs. and her Support
 With the Children during her widowhood & my part of the
 negroes left to us by her Father. Item I give and bequeath
 unto my beloved Daughter Jane. Cannon two hundred dollars.
 Item I Give and bequeath unto my beloved Daughter Sarah. Cannon.
 two hundred Dollars. Item I give and bequeath unto my Daughter
 Susannah. Cannon. two hundred. dollars----

Will Continued. Item: I give and bequeath unto my beloved
Sons George, Pliner. Cannon. and my son: James Henry. Cannon.
all my Lands. to be equally Divided between them :Item. I
give. old. Jack and old Rachell their freedom.---.Item: it is
my. will and desire that all the remaining Part of my Estate.
Shall be Equally divided between my five Childred. Jane:
Sarah. George, Pliner. Susannah. and James Henry. That is to
say as each on marrys or arrive to The Years of Twenty one.
Shall Receive its full part and The Remaining. part to
Continue on the Plantation it is also my desire that if one
of the Children Should die. without a --Child. that its part
Should be equally divided amongst The rest of My Children.
NEVERTHELESS . it is my will and desire that if any of the
negroes will not be controlld they Shall be Sold by my
Escectitors and others purchased, and put in. their room It
is my. will and desire that the Executors Shall. buy or
Sell as they think proper for the use of the Estate Item. it
is my. desire. that my. Children. Shall be Schooled out of the
Estate at the discretion of my. Executors. Item. it is my
and desire that. Rasha Cannon. & his. wife Shall have my
Daughter Jane. to bring her up and for her Support to Come
Out of my. Estate. I do. Make. ordain Constitute & appoint
Rasha, Cannon. & Aleseander. Fountain & Bright. Williamson.
& Thomas, Park: my whole. and sole. Esecutors. of this my
last. will: and Testament disannuling. and Revoking all other
wills by me made.---
