and Children and her with her Increase to be Sold and equally  
Divided amongst my Children at the Increase of my beloved wife  
I Likewise Constitute make and ordain George James Exeutor  
my wife Clercy Cole Exeutaix and Isaai Cole the Sole Exeutor  
& Etx. of this my last will and Testament by them to be freely

to be Posesed & Enjoyd & I do hereby utterly Disalaw Revoke  
& disornul all & Every other former Testament Legoeice Bequests  
& Exacators by me in anewis mentioned wills & bequesthed  
Ratifieng & Confirming this as my last will & Testament in  
Witness Where of I have here unto Set my hand & Seal this Ninth  
day of march one thousand Eight hundred three
