Elizabeth John & Selas Item I lend One feather bed and furniture to my wife her life or widowhood and after her decease or Widowhood to be divided. between my Two boys Viz John & Silas Item I lend to my wife two pots and One dutch Oven One dish Six plates One Case Knives & forks One Wolen wheel & One Pair of Cards diving her life or widowhood when to my tow Boys Item I give to my Daughter Elizabeth One feather bed & furniture One large Chest Item my will & desire is that my wife Should have as many of my hogs as my Executors Should think a plenty for her use for One year my desire is for her to have what cow is made for her use, Item my desire is that my Crops of Cotton Should be Sold & Cattle to pay my last debts and the Remainder of my hogs if any left after She is furnished to be Sole with the Cattle & Cotton Item I lend all my working Tools to my wife for her use during her life or Wodowhood and lastly I Constitute nominate and appointing my

beloved friend James Rufell and my well beloved wife Anna Revell
