I give and bequeath to my son Micah Mixon two hundred acres of land that I had Rights Signed by William Belk two hundred acres Secured by my myself lying on both sides along branch also one Negro Girl Called Rose & her Ijue & Increase also one Negro boy Dalled Cuffey for the term of ten acres, then for the Negro boy Cuffey to be Returned into my Estate to be disposed of as is to be mentioned herein one brights bay Have one Feather bed & bouster two two blankets two sheets to him & his heirs forever.

Item I give and bequeath to my Daughter Anna Fifteen Dollars to be raised out of my Estate I lend my Daughter Anna one Negro boy Called Heard Dureing her Natural life for her own use and profit, at other Death I give and bequeath the said Negro boy Heard unto my grand son Elihu Belk to him and his heirs forever-- ----
