p.331 Conrod Lowery Senr to Shemuel Nicholson, Deed, 6 February 1817, One thousand Dollars, 286 acres by resurvey made by Jesse Blocker D.S. on Rockey and Stevens Creeks of Turkey Creek, Stevens Creek and Savannah River, being part of two bounty tracts originally granted to John Jacob Messersmith and Andrew Markes. Adj Wright Nicholson, Joseph W Nicholson. /s/ Conrod Lowery. p.333 Hannah Lesesne of Charleston, widow, extx of will of Isaac Lesesne date 15 November 1792, decd, to Edmund Bacon, attorney, Deed, 20 May 1816, Will appointed Thomas Winstanly and his son Isaac Lesesne on his arrival at age, executors; Hannah alone qualified, Four hundred Dollars, 500 acres originally granted to afsd Isaac Lesesne decd on 1 June 1775 situate in Granville County on branches of Beaverdam of Stevens Creek of Savannah River, now lying in Edgefield District, adj at time of grant on land of sd Isaac Lesesne, land surveyed by Richland, Daniel Rogers, Simkins, resurvey of Stephen Tillman Esqr 6 September last. Wit George Petre, Sarah Merchant, Mary Lesesne. /s/ H Lesesne. Proven 27 May 1816 by Isaac Lesesne [who said he had signed]; G M Bauetheau JQU. Rec 4 December 1817.

p. 336 Hannah Lesesne of Charleston, extx will of Isaac Lesesne, merchant, decd, to Edmund Bacon, Deed, Four hundred Dollars, land originally granted unto sd Isaac Lesesne 1775 500 acres on branches of Beaverdam Creek of Stevens Creek of Savannah River adj lands of sd Lesesne, Richland, Daniel Rogers, Simkins, [blank] survey by Stephen Tillman 6 September 1815. fifty cents, 83 ½ acres purchased by me from Saml Walker lying on Beaverdam and Shaws Creeks adj lands of Benjamin Frazier, Widow James, Widow Eddins, Benjamin Darby. Wit James Kerbee, William Close. /s/ Abner Landrum. Proven 29 November 1817 by William Close; Lewis Miles QU. Rec 8th December 1817.

p.342 Thomas Youngblood Senr to Moses Odom, planter, Deed, 29 December 1811, Fifty five Dollars, 25 acres on Ephraims branch of Sleepy Creek of Savannah River, adj lands of William Odom. Wit William Odom, James Odom. /s/ Thomas Youngblood Senr. Justice Dionysius Oliver certifies relinquishment of dower rights by Amy Youngblood wife of Thomas Youngblood Senr, 25 July 1813; /s/ Amy (x) Youngblood. Proven 17 July 1813 by William Odom; Dionysius Oliver JQ. Rec 8th December 1817.

p.344 Isaac Kirkland to Moody Bettis, Bill of Sale, 25 April 1812, Three hundred Dollars, Negro girl Dice and future increase. Wit Francis Bettis. /s/ Isaac Kirkland. Proven 25 April 1812 by Francis Bettis; Matthew Bettis. Rec 8th Decr 1817.

p.345 Zacheriah Smith Brooks to John Riley and Jeremiah Riley exrs of will of William Riley decd, 10 December 1817, Three hundred Dollars, sale not completed before Wm Riley's death, now completed, 100 acres on Big Creek of Saluda River, heirs of James Riley deceased to take only the part to which their father would have been entitled, taking equal share: John Riley, Jeremiah Riley, Enoch Riley, George Riley, Samuel Abney who married Mary Riley, William Marler who married Elizabeth Riley, all heirs in law of William Riley and children of James Riley decd; after death of Amelia King late widow of William Riley, deceased, reserving unto sd Amelia King a life estate in foregoing premises and after her death unto sd heirs. p.347 Buckner Blalock to Ezekiel Perry, Deed, 8 August 1817, Eight hundred fifty Dollars, 500 acres on Bech[Beech?] Creek of Edisto River, being part or all of four tracts conveyed to me, two of them by Benjamin McKinne, and by Joseph McKinne, and the other by Jeffcoat, and runs as follows, adj lands of Mrs Blaylock, Bruce, William Holston Senr, myself, Bell, William Holston Junr, James B[lost in binding], John Blaylock. Wit Andrew T Perry, Matthias Jones. /s/ Buckner (M) Blalock. Justice Peter Lamkin certifies relinquishment of dower rights by Ann Blalock wife of Buckner Blalock, 18 August 1817; /s/ Ann (x) Blalock. Proven 18 Augt 1817 by Matthias Jones; Peter Lamkin QU. Rec 13th December 1817.

p.350 Henry Parkman to John Bolger, Deed, 2 December 1817, Seven hundred seventy Dollars, 140 acres on Big and Little Mountain Creeks, on the Long Cane Road, it being part of land originally granted to Jefferson Williams in 1768, adj lands
