I allow all my Just debts to be paid out of My crop hen finished and gathered in Also all the debts which My daughter Lucy Woodward has contracted previous to this date out of the Crop, Also I give and bequeath unto My daughter Sarah Riley 1 Bay Horse, half of My Stock of Hogs, Also one half of whatever Remains of my Crop after the above debts is Paid and the Hegroes is Supported until the Crop is finished Also the Whole of my Household furnature, ith all my Cloathes xcept 2 beds & furniture, Also I give and bequath unto Ly Son Henry Woodward the remaining half of my stock of Hoga also I give and bequeath unto my daughter Clizabeth McMorries ONe bed and furnature, Also I give and bequeath Unto My daughter Lucy Woodward one bed and all the furnature that She Now Claims And that I have given off to her Also as Euch Corn and fodder as is Sufficient for one Horse, Then the Balance of my property I give and bequeath as follows, VIZ. Then the Crop is finished, the remaining part of the Same with the property Not Mentioned Shall be Sold and be qually divided between Benjamin Hay, Thomas

I allow all my Just debts to be paid out of My crop Then finished and gathered in Also all the debts which My daughter Lucy Woodward has contracted previous to this date out of the Crop, Also I dive and bequeath unto My daughter Barah Riley 1 Bay Horse, half of My Stock of Hogs, Also one half of whatever Remains of my Crop after the above debts is Paid and the Hegroes is Supported until the Crop is finished Also the Whole of my Household furnature, ith all my Cloathes Except 2 beds & furniture, Also I give and bequath unto Ly Son Henry Woodward the remaining half of my stock of Hogs also I give and bequeath unto my daughter Elizabeth McMorries ONe bed and furnature, Also I give and bequeath Unto My daughter Lucy Woodward one bed and all the furnature that She Now Claims And that I have given off to her Also as Much Corn and fodder as is Sufficient for one Horse, Then the Balance of my property I give and bequeath as follows, VIZ. Then the Crop is finished, the remaining part of the Same with the property Not Mentioned Shall be Sold and be Equally divided between Benjamin Hay. Thomas May, Elizabeth McCorries, Jane Freeman, Lucy Woodward, Jos ph Woodward and Henry Woodward, OWly fifteen dellars I will and bequeath to the Heirs of my Son Tho. Woodward lastly I do constitute ordain and appoint Josep woodward An Executor, to this My last Will and testament, ANd I do hereby Revoke, Disannul, and disallow all former Wills or testaments and do hereby declare this to be my last will
