Give my Dendue money to be divided equally between my two sisters Jane Milling and Sufanna Quarrel, after there is First taken out of the same as much money as will purchase a suit of Clothes for David Milling my Nephew. 5th I give to Mrs Margt. McCreight my Hat; and all my other body Clothes to be divided between my Sister Jane Milling and her two Daughters. Sarah and Mary- Ann Milling, 6th I give to Esther Dunhap of Kershaw County one Mare Colt 7th I Give to my sister Lettece Butchison ten shillings 8 . I Give to my sister Martha Miller ten shillings ster 1. And I do hereby author-Fire constitute and appoint M : Samuel W. Youque Sole
