I give demise and dispose of thesame in the following manner and form that is to say First it is my will and pleasure that my funeral charges and all my Just Debts be first paid ITEM I give devise and bequeath thirty seven acres of land situate in Peters Township in cumberland county and province of pensylvania be the same more or less to the use of Baptist Society under Commands of God and profess the faith of Jesus Christ in the same faith forever ITEM- I give the use of the plantation whereon I now live containing two hundred and fifty acres together with all my household furniture plantation tools and stock of what kind or nature soever to my beloved wife Abigail Owens during her natural life- ITEM I Give devise and bequeath the plantation whereon I now live after my wifes decease to my beloved son Samuel Owens his heirs and assigns forever ITEM It is my will and pleasure that all the remaining part of my Estate of kind or nature soever after the decease of my beloved wife be appraised and equally divided between all my children share and share alike- lastly I do hereby constitute ordain and appoint my beloved wife Abigail Owens sole Executrix of this my last Will and hereby disanulling and making void all former Wills Legacies and Executors by me heretofore made Ratifying and confirming
