year of our Lord Christ One Thousand seven Hundred and Eighty  
Seven Between Robert Prince of the County of Greenville and State  
of South Carolina of the first part, and Martin Adams of the State  
of Virginia of the second part. Witnesseth that the said Robert Prince  
for and in consideration of the sum of Twenty five pounds Sterling  
money to the said Robert Prince in hand paid by the said Mar-  
tin Adams at and before the sealing and delivering of these pres-  
ents the Receipt thereof is hereby Acknowledged and thereof and  
from every part and parcel thereof doth hereby acquit the said  
Martin Adams by these presents. Hath Granted Bargained  
Sold Alien'd Released and Confirmed, and by these presents doth  
Grant Bargain Sell Alien Release and Confirm unto the said  
Martin Adams in his actual possession and to his heirs and assigns for-  
ever all that tract or parcel of land situate lying and being in the said Coun-  
ty of Greenville District of Sandy Six on the Branches of Beaverdam  
Creek Surveyed for Stacy Hooper the Nineteenth day of July in the  
year One Thousand seven Hundred and Eighty four, and was Granted  
the said Robert Prince by William Moultrie Esquire Governor of the  
said State of South Carolina with the Great seal of the state thereto  
annexed Bearing date the sixth day of February Anno Domini One  
Thousand seven Hundred and Eighty six, and Bounded as followeth  
Beginning at a white oak, and Running N Seventy W. Thirty nine  
Chain to a poplar thence N Twenty E Twenty seven Chain to a post  
oak, thence South Eighty East Thirty one Chain to a Red oak,  
thence South Forty East Thirty Chain to a post oak, and from  
thence to the Beginning white oak, containing one Hundred and  
Forty and four acres within the said Courses and Boundaries  
together with all Houses, Orchards, Gardens, Fences, Woods Trees  
Fishing profits Commodities, Advantages, Enrolments, Privi-  
leges and Advantages whatsoever to the said land belonging or  
in anywise Appertaining and the Reversion Remainers  
Rents Issues and profits of the said land and Premises with  
the appurtenances and all the Estate Right Title Interest  
Property Claim and Demand whatsoever both in law and Equity  
of the Robert Prince or his heirs of or to the said land and prem-  
ises with the appurtenances thereto belonging and all deeds Wit-  
nesses and Evidences belonging or Concerning the said land and  
To have and to hold the said one Hundred and forty and

lands or assigns hereby Covenant grant and agree to and with the said  
 Martin Adams his heirs and assigns in manner and form follow-  
 -ing that is to say at the time of executing these presents he the said  
 Robert Prince is an extender seized and possessed of a good sure and  
 absolute and Indefeasible Estate of Inheritance in fee simple in the her-  
 by Granted Bargained and sold land and Premises with the appurte-  
 -nances and free and clear of all Jointers, Dowers, Rights and Title of  
 Powers and that he the said Martin Adams his heirs and assigns  
 may and shall from time to time and at all times hereafter have hold  
 Occupy Possess and enjoy all and singular the hereby bargained and  
 sold land and premises with the appurtenances, with a Warranty  
 of the Right and title hereof to the said Martin Adams his heirs  
 and assigns forever, and Lastly that he the said Robert Prince his  
 heirs and assigns will at any time hereafter make and Execute any  
 other Deeds or Conveyances on the said Martin Adams or his heirs  
 shall Reasonably Require for the more sure binding and securing the  
 Right of the said land in fee simple to the said Martin Adams and  
 his heirs forever, and to the true performance of all articles matters  
 and Covenants herein contained the said Robert Prince do bind him-  
 -self his heirs and assigns to the said Martin Adams and to his heirs  
 and assigns in the Penal and full sum of five Hundred pound ster-
