 and my Desire is that all my just Debts be paid by the Sale of
 what personal Property as is not hereafter mentioned or if my
 Executrix or Executors should think it best, by any part of
 Real property, and as to the Remainder of my Wordly Estate which
 the Lord hath blast me with I give and Bequeath to my Beloved
 Wife Amelia Daniell the use and priviledge of any, part or parcel
 of ^{my} real property for Cultivation during her natural life or
 untill my younger Children comes of the Age of Twenty One Also
 I give and bequeath to my Beloved Wife the use of all my House-
 hold furniture, my Steek of Hogs and Cattle Except what may be
 hereafter mentioned with all plantation Carpenters and Other Tools
 on the plantation of mine, Provisison, Bees &c, to be to her use
 during her life and after her Death the remainder or remainders
 I give to be equally divided between my Daughters Mary M Daniell,
 Sarah A Daniell and my two Sons Robert and Josiah Daniell and also
 A Negroe Woman named Yansky with her Increase in the same Manner
 as the Above -----

Item I Give unto my Loving Dughter Elizabeth Vereen and my two
 Sons John and Lewis Daniell all of the property which I have al-
 ready given into their pefeeseion to be to their Own ^{use} and behoef
 forever with Increase Item and give to my loving Daughter Mary
 Michel Daniell One Yong negroe woman named Gloc with all her
 future Issue, One Feather Bed and Furniture and also a Heigher,
 Item and Give to my loving Son Robert Daniell one negroe boy Ben;
 One Feather Bed and Furniture with a Cow and Calf, Item and Give
 to my loving Son Josiah Daniell a Girl Hannah and Issue One
 Feather Bed and furniture with Heigher Item and Give to my loving

Bed and Furniture with a Heigher Also my desire is that if
any one of my four last mentioned Children should loose their
Negree herein Given that it should be made up to them out of the
property previous to the Divission, and in case Any of my four
last mentioned/ ^{children} should depart this life before they arive to the
Age of Twenty one then It is my Will and desire that the dead
Child or Childs part be Equally Divided between the Surviving
four Children Mary M Daniel, Robert Daniell and Sarrah Daniell
or Josiah Daniell, Lastly I hereby Nominate and appoint my
Beloved Wife Amelia Daniell my Exetrix and John Lewis Daniell
my loveing Sons Executors, (and in case my Beloved wife should
see cause to alter her life by marrying and thereby I give or
destroy the Estate in her peiseision it is my desire that my
Executors should peiseise themselves of it and do the best in their
with-it Power with it for the Surviving Heirs) To this my last
Will and Testament, Perveking and Disannuling all others here-
tofore by me made or done I do Acknowledge this and no other to
be my last Will and Testament In Witnefs whereof I hereunto
Set my Hand and Seal this fifth Day of December In the Year of
Our Lord Eighteen Hundred and four -----
