tion of My Executors hereafter mentioned and as touching my  
Worldly property that it hath pleased God to Blefs me with I Give  
and Dispose of in the following Manner and form here after men-  
tioned -----

first It is my Desire that my Executors as soon as Convenient  
after my Death Shall Sell My two negro fellows George & Ben and  
the Money arising therefrom shall be Laid <sup>out</sup> / in Buying young  
negroes for the use of My family and after the period of Seven  
years have Liberty of Selling Jack & Sam and the money Laid out  
as above for young negroes and them Negroes so bought by <sup>my</sup> Execu-  
tors Shall be Considered as part of my personall Estate and be

of third part of all my Lands During her Life with one fift part  
of all my personall Estate that is to say and Equal Share with my

amongst My Surviveing Children

I Give and Bequthe unto my son William all my Land that I shall  
have at the time of my Death with on feather Bed and furniture  
the Remainder of my Estate be Divided Between My son William &  
Daughters Rebekah Ann & Elisabeth Share and Share alike to  
Receive thair Shares as they arrive to thair Lawfull age but if  
any of My Childreen Should Die Before that time thair Share be  
Divided amongst My Surviveing Childreen -----

Lastly I nominate Constitute and apoint My Father inlaw Adam  
Jordan and Rich, Green <sup>&</sup> <sup>Sr</sup> Executors to this My Last Will and test-  
ament to pay my Just Debts and to See My Estate / as above  
Directed and I do hereby Revoke and Disanul any other will or  
Divided

and Constitute this my Last Will and testament first I Give my Soul to God that Gave it and My Body to be buried at the Discretion of My Executors hereafter mentioned and as touching my Worldly property that it hath pleased God to Bless me with I Give and Dispose of in the following Manner and form here after mentioned -----
