Edward Bonner's Estate continued

Decr. 17. 1844. Sent letters by mail to Edward Mansfield directed to Friendship Burlington District S.C. to Edward Bonner at same Post office Wm. Hummer. at same Post office Dennis Hankins Johny Luke, John George. Reaves John Reaves & Edward to Reaves Smithville S.C. Wm. Gore Lurfe at Bossers P.O. Columbus S.C. and advertisement sent to E. Waterman same day also Wm. Brewer at Milledgeville Ga.

March 15 1845 being the day on which the term expired by law for advertising for absent heirs Consent for sale of the lands having been made by Reaves Hankins Lucian & Graham.

It is decreed that the lands of the said Edward Bonner lying lying on Hulls Islands consisting of one tract of thirty three acres bound on SE by Grifpelt's land on the SW by Bonner's land and sold by George H. Grifpelt to Edward Bonner 15 Aug 1819 and by him transferred to Edward Bonner 14 March 1825-

2^d One tract 400 acres granted to John Cox 2^d June 1773 on S.W. Branch of Back Creek Swamp and transferred from Lepe Cox Mary Cox and Mercy Cox as heirs and legatus of John Cox to Edward Bonner dated 12 Feby 1817.

3 The right & title of E Bonner to 467 acres being part of 1000 acres granted to John Cox in 1792 as per recovery made by Dennis Hankins the day of Decr 1825.
