being in a low State of health tho of a Sound disposing
memery do make and Constitute this my last will and testament
in the followings maner first I give my Soule to god who give
it me and my body to be buride in a Christian manner at the
discretion of my Excuters hear after mentioned and as what
worldly goods it hath pleased god to blefs me with I will and
bequath in the following Manner -----
Item I lend unto my beloved wife Deuteronomy my plantation
where on I Now live with all my household furniture and planta-
tion tooles and man mill and all my Vefuels to ~~half~~ ~~the~~ ~~land~~ ~~at~~
hur owne disposhel during hur natual life or widowhood this
under the Cear of my Son John Cannon Grainger untill my son
Allen Coms of age also my Stock of Cattle and Higgs -----
Item I give and bequath to my Son John C Grainger one Shilling
Sterlin -----
Item I give and bequath to my Cosen John Grainger Seven hundred
and twelve acers of land whaar on John Felley now lives to him
and his heirs for Ever -----
Item I give and bequath to my son Harvey Grainger two hundred
acers of Land it being the tract I bought of William King on
the North Side of play Card Swamp to the first run -----
Item I give and bequath to my son Allen my plantation where on
I now Live to be his at his mothers Death or marrag also one
hundred acers of land jeyning John Lewis land in pleasent
meadow Swamp alfs one Rifol gun and one pear Stillards -----
Item I give and bequath to my Doter Nancey Harper one Shilling
Sterlin
Item I give and bequath to my Doter Miarn Demern one Shilling
Starlin
Item I leave the reste of my lands and one lot in Conway brough
and ~~all~~ ~~the~~ ~~tooles~~ ~~to~~ ~~be~~ ~~Sold~~ ~~by~~ ~~my~~ ~~Excuters~~ ~~and~~ ~~after~~ ~~all~~
my Debts is payd I leave the rest of my Estate to be Equal
divided Between my three yeeungs Childern -----
I do hereby Constitute my Son John Cannon Grainger and Benj

Solely my Executors to this my last will and testaments in
witness where of I have here unto set my hand and Seal this
twenty second day of September 1895 and in the 29th year
of American Independency -----
