The State of South Carolina George Town district Kings Town County, In the Name of God Amen I William Snow of the State & district & County Afferesaid, Calling to Mind the Mortality of human Nature that Man was born to die, I being in perfect Mind And Memory haveing the full Excercise of my faculties do hereby Make this my Last Will and Testament First I Recomend my Soul to Almighty God that Gave it & my Body to the Earth to be decently buried by my Executors hoping at the Resurrection for my Soul and Body to be United Together Trusting in the Merits of my Blefed Saviour Jusus Christ for the pardon of my Sins And With what it hath Pleasseed God to Blefs me with I order my Worldly Goods (As follows, That is to Say, I Give my wife Margrat the four following Negros to her for ever, Philand Yerke Charlotte Sary with there Increes) And I Allse Lend my wife Margrat these four Negros Clarett Mary John Deborah during her Naturel Life and ather Death the Last four Negros with there Issue Shall Revert to my Son Samuel N. Snow and the Lawfull Issues - And Issues of his Body forever, Allse I Lend my wife one third of all my Stocke of deferent kinds with there Increes and One half of my house hold and kitchen furniture and at her Death the Stock of deferent kinds with there Increes with the furniture to Revert to my Son Samuel and to the Lawfull Issues & Issues of his Body (And - Further I Give my wife full Liberty for her Own youse Not to dispose of Any of my Timber and Litewood to worke it for her Support And further I Give my wife Margart full Liberty to worke any of my Lands for her Support And full Liberty to Live in my house And I Give my wife my Rideing Chear and Equal part of plantien Tools to worke the Negros I Left her

ever Lastly I Nominat my Son Samuel One of my Executers and to be
of Age and Receive his Estate At the Age of Nineteen Years Old, And
my one wife one of my Executriets And W. ^M Davies and Cap. Keth of -
George Town and Cap. Henry Durant my Other Executers to this my
Last Will and Testament, In Witnefs I hereunto Sett my hand And Seal
this 20 day of May 1802 And In the 26 Year of the Independance of the
United States of America
