of the District of Kershaw and State of South
Carolina being of good health and of sound
mind and disposing memory Thanks be to
almighty God, do make constitute and
Ordain this my last Will and Testament
Hereby revoking all wills or wills by me
heretofore made First of all I recommend
my soul to god who gave it me and
my body to be decently buried in a
Christian like manner at the discretion
of my Executors, And as touching what
Worldly Goods it has pleased God to
endow me I Give and devise in man-
ner and form following (that is to say)
It is my will and desire that all my
Just debts should be first paid,
Item I Give and devise unto my Loving Wife
Pernelly Kirkland the House and as much
of the plantation as she can tend and culti-
vate together with all my Household and
Kitchen Furniture, Four Negroes such as she
may make choice of, Two Horses of her own
choosing, ~~Ten head of~~ Ten head of Horned
Cattle Ten head of Sheep and Twenty head
of hogs, for and during her natural life
and at her death it is my will and
desire that the above recited property as
Given to my Wife Pernelly should be
equally divided between my Two sons
Amosel Kirkland and Joseph Kirkland
to them and their heirs forever
It is my will and desire that my Land
should be divided by a line of

Beginning at a ford on the piney Branch known
 by the name of Burger's Ford Thence to the
 corner of Jacob Coles old field being mainly
 a North and South course. And all the
 Land that should be to the West side
 I give and devise to my son Samuel
 Kirkland to him and his heirs forever.
 Item, I give and devise to my son Joseph
 Kirkland all the Land that may be to
 the East side of the Above rectified line
 to him and his heirs forever, I Give and
 devise unto my Two Sons Samuel
 Kirkland and Joseph Kirkland all
 the Rest and residue of my Estates of
 every kind and description whatever
 to be equally divided between them
 to them and their heirs forever.
 Lastly I nominate and appoint my
 Two sons Samuel Kirkland and
 Joseph Kirkland Executors to this
 my Last will and Testament in
 Testimony whereof I have set my hand
 and affixed my seal this Tenth day
 of October in the year of our Lord
 One thousand Eight hundred and
 Twenty and in 45th year of our
 foundation
