In the name of God Amen I Thomas Dixon of Kershaw District
in the State aforesaid being ~~x~~ ^{weak} in Body but in perfect mind
and memory blessed be Almighty do make and publish this my
last Will Testament in manner and form following that is to
say First I give and bequeath unto my dearly beloved Wife Mary
Dixon the plantation Whereon I Now live containing one hun-
dred and twenty Acres with my dwelling Houses household furni-
ture and all the improvements thereon Also another
Tract of Two Hundred and Eighty Acres lying on the fork of
Rocky Mount and White oak Road half a mile above the Granies
Quarter ~~Bruges~~ ^{Gummers} ~~Bruges~~ ^{Bruges} one Gray Horse and one Bay Mare, to-
gether with all my Stock of Hogs and half my Stock of Cattle,
Also my Negro girl named Nancy all which I give to her dur-
ing her life time Also I give and bequeath to my Daughter
Elizabeth Fifty Dollars in Cash Also one hundred Acres of
land above the Mouth of ~~the~~ ^{Gummers} Granies Quarter Creek on the Wateree
River Also one other Tract of Fifty Acres adjoining there-
to on each Side of Granies Quarter Creek Also one Rose Gild-
ing Which is to be Sold and the money applyed to the School-
ing her, as also the other Half of my Stock of cattle In
case my Wife should die before my daughter then and in that
case all all and Singular my Real and personal Estate to de-
scend to my daughter Elizabeth excepting the within mention-
ed Negro girl Which at her option to dispose of as She sees
cause but in case of the death of my Daughter Elizabeth and
wife Mary then the Within mentioned Tract of one hundred and
twenty acres of land Whereon I now live to ~~x~~ ^{John D. Maxwell} and the other on
the fork of the Rocky mount and White oak Road
fall to my Nephew John D. Maxwell and the plantation on the
River containing one hundred acres to Henry Maxwell And the
other Tract of Fifty Acres to James Maxwell-- and lastly I
do hereby appoint My Wife Mary Dixon Executrix and John D.
