Daniel a ne ro Boy named Samuel about five years of age to him
and his heirs and assigns for ever I have theretofore given my
daughter Elizabeth Moor a negro girl named Grace and all of the
above Specified ne roes I have bequeathed and are Expressly given as
an Equal dividend I have given my daughter Elizabeth Moor a filley
and it is my will that she be intitled at the final dividend of
the Residue of my Estate not Specifically willed at the Sum of
Eighty doll rs no intrest or increase to be accounted for an Said
Dividend. I give and bequeath Unto my Son Thomas a Sarrvel
Gilding about five or six years old at the price of Eighty Dollars
which Sum alone is to be accounted for at the final dividend--
I give and bequeath Unto my son Mathew a Colt--about two years
old worth forty dollars to be accounted for at a final division
of my estate without intrest or increase in Value-- I give & be-
queath to my son Joel a black Filley about two years old worth

without interest or increase in Value I give and bequeath to my
son Mathew my Rifal gun not to be accounted for an a division I
give and bequeath to my sons Mathew and Joel a small negro child

named Anne about Nine years of age to them there heirs and assigns
for ever and is not to be accounted for an a final division I will
and desire that all the Rescude of my Estate beath Real and per-
sonal be sold at the death of my wife or Harridge and to be
Equally divided among My Children-- and Lastly I do constitute
and appoint Eliz Brook John Burton and James Boyd Executors of this
my Last will and testament hereby Revoking all other and former
wills and testaments by me heretofore made-- In testimony whereof
I have hereunto set my hand and seal this the fifth day of Oct-
ober one thousand Eight hundred and twenty five-----
