HENRY WILLIAMS

In the name of God amen I Henry Williams of Marian District and State of South Carolina being weak in body but of Sound disposing mind and memory do make this my last will and testament in manner and form following

1st, I give to my Son Henry F Williams my hand mill

2nd I give to my Son Richard G Williams my negro man Moses on Conditions that he pay to my Son Henry F Williams eighty seven dollars and fifty Cents and to my daughter Ann R Williams the Sum of eighty Seven dollars and fifty Cents and to my two grand children Wilson G Williams and Elisabeth Ann Williams the Sum of of forty three dollars and seventy five Cents each

3rd I give and bequeath to my daughter Ann R Williams all my household and kitchen furniture her mothers and her own bed and furniture also her Choice of my horses also it is my will that my executors herein after to be appointed do soon after my death make a title to my daughter Ann R Williams to the three following tracts of land lying in Georgetown District one of which Contains one thousand acres known by the name of Samples mill one other Containing four hundred and Seventy five acres also one other tract Containing five hundred and thirty acres an long Branch

4th I give to my grand son Wilson G Williams one tract of land Containing nine hundred and thirty acres being in Georgetown District being the place whair I formerly lived also one other tract Containing three hundred and Six acres being in marian District the place wher swain lived

5th I also give to my grand daughter Elisabeth Ann Williams one tract of land in Georgetown District Containing Seven hundred and eighty acres known by the name of the owens place and I do hereby authorize my executors to make to the Said Wilson G Williams a title to the two tracts given to him soon after my death but Should my before named grand daughter Elisabeth A Williams not return and Clame her said tract of land by the third day of February one thousand eight hundred and fifty eight then and in that Case it is my will that my executors do make a tile to the lands before mentioned to my grand Son William I Williams; it is my forther will that my other horse and my working tools be Divided between Henry F Williams Richard G Williams and Wilson G Williams Share and Share alike it is my forther will that my beds and furniture

and Books except my family Bible which I give to my daughter Ann R Williams be divided between my three Children Henry F Williams Richard G Williams Ann R Williams and my grandson Wilson G Williams Share and Share alike It is my further will that my Stock of Cattle be divided between my two Children and two grand Children in manner following to my Son Richard G Williams I give one third part and to my daughter Ann R Williams I give one third part and the other third to be divided between my two grand Children Wilson G Williams and Elisabeth A Williams It is my further will that my Stock of hogs and Sheep be divided between my own three Children Share and Share alike--

Lastley I do hereby nominate Constitute and appoint my Children Henry F Williams Richard G Williams Executors and Ann R Williams executrix to this my last will and testament hereby revoking all others by me heretofore made in witness hereof I have hereunto Set my hand and Seal this eighth of April one thousand eight hundred and forty three Signed Sealed published and declared by the testator to be his last will and testament in the presence of us who at his request and in his presents and in the presence of each other have Subscribed our names as witness thereto
