 lives Deeded to me By John Ford also Fifty Acres which I purchased from W.^m,
 Morgan also one Cow and calf one Sow and Pigs which he has Lent I give unto
 my beloved Sone Isaiah Smith one hundred & Fifty Acres of Land which I pur-
 chased from Benj Lewis called the Alagaten track one Bed one sow and pigs
 which he Has lent I give unto my beloved Son Moses Smith one grey Horse one
 Bed one sow & pigs which I have Lent him I give unto my beloved Daughters
 Sarah Perriitt Anna Bason and Rachel Stewber one Hundred Acres of Land which I
 bought from W.^m, Mancill which he purchased from John Campell Executor of
 each of them
 Jeremiah Pain Also one Bed to ~~which~~ ~~of them~~ which they have Lent I give unto
 my beloved daughter Hanner Smith Fifty Acres of Land granted to me from W.^m
 Morgan Being part of the track of which I gave my sone James Fifty Acres one
 Feather Bed I give unto my Daughter Druciler one Sow and pigs which She has
 Received one Feather bead also Fifty Acres of Land where She now Lives after
 her Deth to belong to Her son Moses I give unto my beloved Daughter Martha
 Jane Eighty Acres of Land Granted to Me from W.^m, Hill one Bed & furniture
 It is my wish that whatever property may be found Remaining after the above

 Devide among my Lawfull Hiers and I do here By nominate and appoint my

 and Confirmeing this to be my last will And testament Sined sealed & acknow-
 ledged this 19,,th Sepr 1843 and the Sixty seventh year of American Inde-
