I Redding Moore of the State and district aforesaid, of Sound and disposing, Mind, Memory And Understanding, do Make And ordain the following as My last Will and testament -

1 I give And bequeath to My daughter Elisabeth L. Smith, Thirty Acres Land binding on John Smith land, running a Strait line from John E. Collins to C. J. Crowford land, to her And her lawfull Children forever.--

2 I give And bequeath to Nancy F Kennedy Thirty Acres land - binding on Elisabeth L. Smith land to hir And hir lawfule Children forever And it is My Will that if the Said Nancy F Kennedy Should die without Children, than the $S_{\frac{d}{2}}$ land to be equely ~~///~~ ^{divided} between - William J. Moore, & Elisabeth, L. Smith

3 I give And bequeath to My Son William James Moore all the balance of land lying on the East Side of the Branch, the boundry line b egining on C. J. Crowford line, and thence running ~~///~~ ~~///~~ to Jefsey - Hamptons line, than up $S_{\frac{d}{2}}$ line to Cart Road where $S_{\frac{d}{2}}$ road crosses a certain drain, then turn down $S_{\frac{d}{2}}$ drain to the Branch, than down $S_{\frac{d}{2}}$ branch to C. J. Crowford^s Corner to him and his lawfule children forever,

And it is My will that if he Should die without Children than $S_{\frac{d}{2}}$ land to be equely divided between My two youngest Sons (to wit, Elany Johnson And Joseph Jelly -

4 - I give And bequeath to My Grand Son Stephen R. Moore, all the Land lying North of a Strait line from Bonds Corner, to the Branch, than up the branch to William J. Moore^s line than up the drain to Jefsey Hampton^s line than running $S_{\frac{d}{2}}$ line to Bonds other Corner than Bonds line down to the beginning Corner- to him and his lawful Children forever, and it is My will that if he Should die without Children that $S_{\frac{d}{2}}$ land, to be equely divided between My two youngest Sons (to wit, Elany Johnson And Joseph Jelly Moore,

5 - I give And bequeath to My Son Calvin Moore one dollar -

6 - I give And bequeath to my Son Samuel Moore one dollar -

7 - I give And bequeath to My grand Son Redding, the Son of Samuel Moore

 8 - I give And bequeath to My beloved Wife all the balance of My land, during her Natural lifetime or widowhood - And it is My will, for my two youngest Sons Blany Johnson and Joseph Jelly Moore, to be raised and educated out of the proceeds of $\frac{3}{4}$ land, And out of other bequeath - hereafter Mentioned, to My Wife -

9 - And it is My Will, at the death or Marriage of My Wife, that the $\frac{3}{4}$ land to be equally divided between My two youngest ^{Sons} Blany Johnson & Joseph Jelly Moore, to them and there Children forever, -

10 - And it is My Will that if Blany Johnson and Joseph J. Moore Shall die Without children, than the $\frac{3}{4}$ land to return to there nearest of Kinn -

11 - I give And bequeath also to my wife the household And Kitchen furniture Stock, of ale description And the growing Crop, that is on the plantation at My decease -

12 - And it is My Will that at the death of my wife or her Marriage, that My household and Kitchen furniture Stock of ale description and the growing Crop that is on the plantation at My decease, Shall be equally devidid between Blany Johnson and Joseph Jelly to them and there Children, forever -

13 - And it is My Will that if they dies without Children, than it to return to the Next of Kinn -

14 - I Nominate, Constitute And appoint as My Executors, My Wife Nancy Moore William J. Moore And G. J. Crawford Witnefs My hand and Seal this fifteenth day of June in the year of our Lord one thousand Eight hundred And forty Nine, and in the Seventy Second year of the Independance of the United States of America -
