I Give to my beloved wife Elisabeth two hundred acres of my Land adjoining James Harrells Land the upper part of the Land that I now Live on and hir choise of my Beds and Bedstide and the Furniture of Said Bed I also Give and Bequeste unto hir choise of one horse and my Riding chare one third of my Kitchen furniture I also Leave unto hir one thousand Dollars at hir discrecion and at the Expiration of Fore Years I give unto hir one thousand dollars more if she survives to that time I also advise my Executors to Build hir good comfortable dwelling house & necessary out Building I also advise my Executors to furnish hir with a sofisiant necessary & provisions the term of Four Years if hir child Lives From my decease I also give hir hir choise of two cows & calves and one half of the geese I also Lend to my Daughter a negro Carl named Ginne if she Lives to surviv to the age of Eighteen Years said Gin is to be hirn For Ever with hir futur increase if she dies before she marreys or arrives to the age of Eighteen the Said Gin is to be sold & the money propriated to the Rest of my Estate I advise that; part of parsonal Estate; be sold on a short credit to pay my Just & Lawfull debts, I also advise that my negresse Be sold on a credit of Fore Years; I also advise that my Lands & tiniments be sold at private or publick sales to the best advantage I also advise after all Just debts and Expences be paid that the Balance of the money be put to Intrest my little daughter that I have by my wife Elisabeth Being abaught Fore months oald not named I advise she be put to school and soported ———— decently as soon as she arrives to proper age to go to school If my wife Elisabeth shold have a child or children within the term of nine months after my Decease I Request that it or they be Likewise Schooled and soported as the other if no other child or children if they shold marry or a Give to the age of nineteen years oald I Give & bequeth unto hir or others if there shold be ary; all my Estate after Giving Leonard white three Hundred dollars in

 Years intrest. of the money be put to the use of the schooling of the

 my Farther & Mothers heirs in Law—

 Executors of this my Last will and Testament ———
