Arising from Eleven Negroes namely Sarah Phoebus Esther Will Bob Tom Rachel
Lenah and Nancy
Mary Sue/and their Increase during his natural life, and if he shall die
leaving lawful Issue I then give said Issue the above named Negroes Sarah
Phoebus Esther Will Bob Tom Rachel Mary Sue Lenah and Nancy and their In-
crease forever, But should their be no such Issue I then give and bequeath
unto my son Collins Woodbery the Eleven above named Negroes, Sarah Phoebus
Esther Will Bob Tom Rachel Mary Sue Lenah and Nancy and their increase for
himself and his lawful Issue forever, And I do hereby Nominate Constitute
and ordain or appoint my Beloved son Collins Woodbery Executor to this my
last Will and Testament, It is also my will that my above named Executor Col-
lins Woodbery shall have full power during his natural life over the above
named Eleven Negroes Sarah Phoebus Esther Will Bob Tom Rachel Mary Sue Lenah
and nancy and their Increase, To Work Hire or in any manner that he may think
will be to the Advantage of my Grand son John Peter Dunnam so that he may Re-
ceive the Proffits Arising therefrom-- hereby Ratifying and Confirming this
and no other to be my last will and Testament hereby denying Revoking and
disanulling all other wills and Testaments whatsoever, In testimony whereof
