Lydia, Sibby Dick Jefse Claracy Harry Carolina and their increase, Item to my Grandson John Peter Dumman Igive the Proffits Arising from Eleven Negroes nemely Sarah Phosbus Esther Vill Bob Tom Rechel Mary Jue/and their Increase during his natural life, and if he shell die leaveing lawful Ifsue I then give said Ifsue toe above nemed Negroes Sarah hoebus Esther W111 Bob Tom Rachel Mary Sue Lonch and Nancy and their Increase forever, but should their be no such If sue I then give and bequeeth unto my son Jolins Roodbery the Eleven above nemed Negroes, Sarah Phoebus Esther Sill Bob Tom Rachel Mary Sue Lonah and Nancy and their increase for himself and his Lawful Ifsue forever, And I do hereby Nominate Constitute and ordein or appoint my Biloved son Colline Woodbery Executor to this my last will and Tostoment, It is also my will that my above named Executor Colline Woodbory shall have full power during his natural life over the above named Kloven Negroes Sarah Phoebus-Sather Will Bob Tom Rachel Mary Sus Lenah and nancy and their Increase. To Work flire or in any manner that he may think will be to the Advantage of my Grand son John Peter Dunnam so that he may Receve the Proffits Arising therefrom— hereby Satifying and Confirming this and no other to be my last will and Testament hereby denying Revoking and discipuling all other wills and Testements Whatsoever, In testimony whereof
