Also I Give to my well beloved daughter Mary Lane Two Feather Beds Stock of Cattle Sheep and hogs which she has in pofsefsion and at the deceas of my beloved Wife a negroe Girl named Hanah- -

Also I Give to my well beloved daughter Prudence Stephenson the Stock of Cattle And Sheep that has been delivered to hir & Two Feather Beds & Farniture that is in hir pofsefsion and at the deceas of my beloved Wife a negroe Boy named Minca - - -

Also I Give to my well beloved Son Briant Jones one Feather Bed and Farniture which he has in pofsefsion And at the deceas of my beloved Wife one negroe Boy named Bille

Also I Give to my well beloved daughter Marthea Jones one Negroe Boy named Buff one Feather Bed and Farniture which she has in

hen Jones Two Tracts of Land Situate on the west Side of Cat-
fish Containing in the whole Two hundred and nine Acres Ori-
ginally Granted to me one negro Boy named London and after
the decease of My beloved Wife one negro man named Cuff one
Cow And Calf one Puter Dish & half Dz plates Also I Give to
my well beloved Son---Thomas Jones one negro Boy named Cooper
one Feather Bed & Furniture one Puter Dish & half Dz plate And
after the decease of my well beloved Wife the plantation where
I now reside Also I Give to my Surviving heirs all and singular
the Property & Interest of Every discription that I may be pos-
sessed of at the time of my decease the property above mention-
ed Excepted to be equally divided There and There Alike
And I Constitute make And ordain My Two Sons Breant Jones and
Thomas Jones And James G Crawford My Executors of this my last
Will And Testament And I do hereby utterly disallow revoke
and disannul all and every other former Testaments Wills Lega-

Also I Give to My well beloved Son Robert Jones one negroe Boy named Bob one Tract of Land Containing three hundred and fifty acres Situate on the N. W. prong of the big Bay of the Myrtle Spring one Feather Bed and furniture one Puter Dish and half Dz plates— Also I Give to my well beloved Son Stephen Jones Two Tracts of Land Situate on the west side of Catfish Containing in the whole Two hundred and nine Acres Originally Granted to me one negroe Boy named London and after the deceas of My beloved Wife one negroe man named Cuff one Cow And Calf one Puter Dish & half Dz plates Also I Give to my well beloved Son---Thomas Jones one negroe Boy named Cooper one Feather Bed & Furniture one Puter Dish & half Dz plates And after the deceas of my well beloved Wife the plantation where I now reside Also I Give to my Surviving heirs all and singular the Property & Interest of Every discription that I may be pofesseed of at the time of my deceas the property above mentioned Excepted to be equelly devided Shere and Shere Alike

And I Constitute make And ordain My Two Sons Breant Jones and Thomas Jones And James G Crawford My Executors of this my last Will And Testament And I do hereby utterly disallow revoke and disannul all and every other former Testaments Wills Legacies bequests And Executors by me in Any wise before named willed and bequeathed ratifying and Cnfirming this And no Other to be my last Will And Testament
