Certain than death and Nothing so. uncertain as the time thereof I; Therefore, have made. and Constituted. this my last. Will And Testament in the Manner form. and ways, following (.That. is to Say.) I. Recommend my Soul to him that. Gave. it hoping that. through the Merits. Death and passion of my Redeemer and Saviour Jesus Christ to have. full and free pardon and forgiveness. of all. my sins and to Inherit Everlasting life and my body I. Commit to the Earth (in assurance of an. Eternal Resurrection) to be decently buried at the discretion of my Executors hereafter Named and as Touching the disposition. of all. Such Temporal. Estate as. It. Pleased the Almighty God. to bestow upon me I. Give and dispose thereof as follows. first of all. I will that my debts and Funeral. Charges shall. be. paid and discharged,. Item I. do Give and. bequeath Unto my Well. beloved son. Nathaniel Gibfon one Shilling Sterling, also. I do. give and bequeath unto my well. beloved. Son. Malichi Gibfon. One Shilling Sterling; also. I do. give and bequeath unto my well beloved Son. John. Gibson one. shilling sterling, also. I. do Give and bequeath. Unto my. well. beloved Son Stephen Gibfon One. Shilling Sterling, also. I do give and bequeath unto my well. beloved Daughter Rhoda. Gibfon one Shilling Sterling. Also. I. do. Give and bequeath unto my well. beloved wife. Mary Gibfon all. my stock of Cattle. sheep hogs, horses. and. all Plantation Tools. and. household Furniture Consisting of whatsoever it may be. at my Decease to be for the ^{use} ~~decease~~ of the ^d Mary Gibfon her lifetime. and at her decease to be and belong. to my well. beloved Son. Tobias Gibfon. also. three Negro. Slaves. Named, as Follows, Sharper Sarah. Judas -I do. give to the above Named Mary Gibfon, to dispose of at. her own will and pleasure And last of all. I do hereby Nominate appoint and Constitue my beloved friends Nathaniel Saunders

and Nathaniel Gibfon my Executors to this my last will and Testa-
ment hoping that they will see do. or Cause to be done and Executed
Every article part or Clause therein Mentioned according to the
true Intent and meaning thereof and. I do. Revoke disannul. and
make. ~~void~~ all other wills and Testaments by me heretofore made
In. Witnefs Whereof I. the s^d Jordan Gibfon to this my last will
and Testamen^t being Contained in one sheet of paper I have. here-
unto set my hand and Seal. the 31^d day of January One thosand
Seven hindred. and Ninety Nine and In the twenty third year of
americas Independancy -
