Should they both Die with out issue then the hole, of Doth Rale & Personaly I Cive & bequeth, to my nephew James W Kee Daniel Son of Mary

Daniel Shold he die without Lewing if sue them. to his mother many Daniel Last with out

Estate to be Devided betwen the thon Living Children of Judah White now wife of Joseph White share & share alike Item I Give & bequeth unto Elizabeth Blackmon forty Dollars in Cash Item Tis my will if Samuel Rourk should die before my mother ann hourk that my Executors to have her a house build as Good a one as Can be for fifty Dollars on any part of my land and to have six square scres around it and to have forty Dollars worth of Corn Pork & Sugar Bought for her each year as long as the Stay on the said land or her life time to be Bout out of the property arising from the rents of my land or labour of my negroes, but if She Should not live on the said Land Sho is not to have the use of it nor to have any part of the forty Dollars no to put any one in the house or to Rent it to any one mor for no one that is any Kin or Relation to the Hourk family to live with her if the do it is my will that the is not to Receive one cent of the forty Dollars nor to be allowed to live on said Land. I likewise make constitute and appoint as my only & solo Executors & Executriz of this my last will and testament Mary Daniel and John Wibfon I do hereby Renounce and Revoke and Disanul all former wills testaments and bequeth by me in any wise made before this tim and Hereby Ratify and Confirm this and no other to be my Last will and testament in witness whereof I have Hereunto Sott my hand, and seal the day and year above writen-sign sield & publicated pronounc and Delivered by the said Rachel Bullard to be her Last will and testament in presence of us the subscribing witnesss - the word deptomber drop out and november interlined before afsign .--
