And as touching such Worldly Estate Wherewith it hath pleased God to blefs in this life, I give devise and dispose of the same in the following manner and Form .-First, I lend unto my dearly belowed wife during the Term of her Natural life all my moveable Estate She paying to my loving Son George One Horse or Mare not under Two years old at the time that he shall arrive to lawful age, my said Wife also paying (in Stock and Household Goods) to my loving Daughters Polly, Selah, Nancy and Tamzen the Sum of Ten Pounds Sterling out of my Said Estate when they shall arrive to lawful age. I give and bequeath to my loving Daughter Sally the Negro Child that my Negro woman Peggy is now great, or big with, ----I give and bequeath to my eldest, and loving Son George the upper or Northward part of the tract of land I now live on, it being divided from the lower part by a line beginning on a large pine on the upper side of a branch Standing at the end of a Dam made a Crof's said branch and running a direct Course along a line of Mark'd trees to Jonathan Marines line, thence Marines line to the Beaverdam, thence the run of the Beaver Dam to the mouth of said branch thence up the Marlboro County Wills

to the beginning--- I give and bequeath to my loving and youngest son Charles all the remainder of my Sd. tract of land which includes the plantation whereon I now dwell--- I give and bequeath my negro woman Peggy with her increase (except what is herein before given) to be equally divided amongst all my loving Children the dividion to be made at the decease of my dear and loving Wife--- Lastly I would tute make and Ordain my said dearly Beloved Wife Sarah my Sole Fxecutrix of this my last Will and Testament and I do hereby utterly disallow revoke and disannul all and every other former Testaments Wills Legacies Bequests and executors by me in any ways before named, Willed and Bequeathed, Ratifying and Confirming this and no other to be my last Will and Testament--- In Witnefs whereof I have hereunto Set my Hand and Seal the day and year, first above Written----
